ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 18-H in the area bounded by

A line 124.55 feet long perpendicular to South Winchester Avenue and 27.50 feet north of and parallel to the public alley next north of and parallel to West 79th Street; the public alley next east of and parallel to South Winchester Avenue; the public alley next north of and parallel to West 79th Street; South Winchester Avenue,

to those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
