**✓ SUBSTITUTE ORDINANCE**


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Institutional/Transportation Planned Development Number 677 symbols and designation as shown on Map Number 1-E and Number 2-E in the area bounded by:

East Randolph Street; a line 725.3 feet east of Columbus Drive (as measured along the south line of East Randolph Street and perpendicular thereto); East Monroe Drive; South Lake Shore Drive; the centerline of East Van Buren Street as extended east where no street exists; South Michigan Avenue; East Jackson Drive; South Columbus Drive; East Monroe Drive; and North/South Michigan Avenue,

to those of amended Institutional Planned Development No. 677, as approved by the Chicago City Council on November 1, 2006.

SECTION 2. This ordinance takes effect after its passage and approval.
