West Monroe Street; the alley next west of South Racine Avenue; the alley next south of West Monroe Street; and a line 202.01 feet west of South Racine Avenue

to those of a B2-3 Neighborhood Mixed-Use District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
