ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M3-3 Heavy Industry District symbols and indications as shown on Map No. 7-H in the area bounded by

PROJECT NARRATIVE

.

PROJECT DESCRIPTION

NRG Clybourn Wrightwood, LLC is proposing the construction of a new 4,335 square foot Chase Bank on an existing surface parking lot adjacent to the Aldi Food Store located at 2564-2586 N. Clybourn Avenue. Chase Bank will be consolidating their two existing in-line branches located in the immediate vicinity. The new branch bank will provide additional services (drive-thru) and will result in additional jobs.

The project requires a rezoning from an M3-3 Heavy Industry zoning district to a B3-3 Community Shopping District, which is a more appropriate district for the bank use. It will also require a Special Use approval to permit a drive-thru operation.

The lot area is 25,422 square feet. The maximum Floor Area Ratio (F.A.R.) allowable is 3.0, while the actual F.A.R. will be 0.17. The proposed building height is 26'- 7". We are providing 12 off-street parking spaces (1 ADA), a screened trash enclosure, and 3,460 square feet of interior landscaping. There are no building setbacks required, but the building will have a front setback of approximately 54 feet (building is angled, so setback varies), side setbacks of 7 feet and 6'-3" at the building's closest points, and a rear setback of approximately 130 feet at the building's closest point.






West Elevation

Drive-up ATM Elevations


