BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 13-32-310 of the Municipal Code of Chicago is hereby amended by inserting the language underscored, as follows:

13-32-310 Permit fees - Computation.

(b) Stand-alone permits- Flat fee. Fees for the stand-alone permit types identified in Table 13-32-310(E) shall be assessed in the amount set forth in Table 13-32-310(E), as follows:

SECTION 2. Section 4-156-300 of the Municipal Code of Chicago is hereby amended by inserting the language underscored, as follows:

4-156-300 License - Required.

(f) No public place of amusement license shall be required if (1) the property is a church, temple, synagogue or other place of worship, or school which has been inspected pursuant to Section 13-20-020 within the 12-month period preceding the production, presentation or conduct of any amusement; and (2) the sponsor of the event is affiliated with the church, temple, synagogue or other place of worship, or school; and (3) all necessary food, liquor and other licenses and permits required by this Code have been obtained.

SECTION 3. This ordinance shall be in full force and effect upon its passage and publication.
