Section 1. That the Commissioner of Buildings is hereby authorized and directed to issue a sign permit to <u>Icon Identity Solutions</u>, <u>1418 Elmhurst RD.</u>, <u>Elk Grove Village</u>, <u>1160007</u> on the behalf of Urban Partnership Bank for the erection of a sign/signboard over 29 feet in height and/or over 144 square feet (in area of one face) at Urban Partnership Bank, southwest corner, of 4659 S. Cottage Grove, Chicago, IL 60653 with the dimensions, height and square foot area:

Dimensions: length: <u>12', 0"</u> <u>Height: 12', 0"</u>

Height above grade/roof to the top of the sign: 29'

Total Square Foot Area 144 sq feet
