Dear Mrs Witkowski:

We recently applied for a loading zone on Wells Street in front of our business. We previously had a loading zone on the Kinzie Street side, but because of the proposed (and now live) bike lane that was put in, we have not renewed that Loading Zone payment since it expired 09/01/10. The signs had been taken down.

Somehow recently, replacement loading zone signs have gone up there, and even further West than our former zone. The poles that have been placed there are affecting our sidewalk café, as it was approved by the city, and since the loading zone is completely unusable, we would greatly appreciate them being taken down.

Attached is all of the paperwork from our last payment of that specific loading zone. The bike lane is a wonderful addition to Kinzie Street and operating under the assumption that it will stay.
