TRAFFIC LANE - TOW/AWAY ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as traffic lane - tow/away zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

1	N. California Avenue (east side) from a point 120 feet north of W. McLean Avenue to a point 20 feett north thereof: 15 Minute Standing Zone, use flashing lights, Tow Zone after 15 minutes, 7:00AM to 7:00PM, All Days - 12-00220068 [O2012-235]
1	N. Paulina Avenue (west side) from a point 20 feet south of W. Division Street to a point 40 feet south thereof: 15 Minute Standing Zone, use flashing lights, Tow Zone after 15 minutes, 5:00AM to 9:00PM, All Days - 12-00668971 [O2012-1043]
3	E. 31st Street (south side) from a point 20 feet east of S. Indiana Avenue to a point 20 feet east thereof: 30 Minute Standing Zone, use flashing lights, 9:00AM to 7:00PM, Monday through Friday and 9:00AM to 1:00PM Saturday - 12-00528193 [Or2012-107]
16	S. Laflin Street (east side) from a point 30 feet south of W. 63rd Street to a point 40 feet south thereof: 15 Minute Standing Zone, use flashing lights, 6:00AM to 6:00PM, Monday through Friday - 11-04144414 [O2011-8156]
20	E. 61st Street (north side) from a point 65 feet west of S. Eberhart Avenue to a point 54 feet west thereof: 15 Minute Standing Zone, 6:00AM to 6:00PM, All Days - 12-00201268 [Or2011-1162]
32	N. Damen Avenue (east side) from a point 115 feet north of W. lowa Street to a point 25 feet north thereof: 15 Minute Standing Zone, use flashing lights, 8:00AM to 9:00PM Tuesday and 8:00AM to 6:00PM Thursday through Sunday - 12-00580907 [O2012-146]
39	N. Keystone Avenue (east side) from a point 115 feet south of N. Elston Avenue to a point 40 feet south thereof: No Parking, All Days, All Times, Tow Zone - 12-00671826 [O2012-711]
