ORDINANCE AMENDMENT Acct. No. 29539 - 1 Permit No. 1070474

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: Section 1:

The ordinance passed by the City Council of the City of Chicago for BEVERLY HILLS TENNIS CLUB on 04/09/2008, and printed upon page 24950 of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words

"Permission and authority are hereby given and granted to BEVERLY HILLS TENNIS CLUB, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Concrete Walls over the public right-of-way adjacent to its premises known as 9121 S. Hamilton Ave...

Said Concrete Wall(s) at S. Hamilton measure(s):

One (1) at fifty (50) feet in length and fifty (50) feet in width for a total of two thousand five hundred (2500) square feet.

One (1) at ten (10) feet in length and one (1) foot in width for a total of ten (10) square feet.

One (1) at two hundred thirty-eight (238) feet in length and two hundred thirty-eight (238) feet in width for a total of fifty-six thousand six hundred forty-four (56644) square feet.

The location of said privilege shall be as shown on prints hereto attached, which by reference are hereby incorporated and made a part of this ordinance.

Said privilege shall be constructed in accordance with plans and specifications approved by the Office of Emergency Mgmt and Communications and Planning Department.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-075 of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1070474 herein granted the sum of three thousand two hundred eighteen (\$3,218.00) per annum in advance."

and inserting in their place the words

"Permission and authority are hereby given and granted to BEVERLY HILLS TENNIS CLUB, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Concrete Wall(s) on the public right-of-way adjacent to its premises known as 9121 S. Hamilton Ave..

Said Concrete Wall(s) at S. Hamilton measure(s):

One (1) at fifty (50) feet in length, and point six seven (.67) feet in width for a total of thirty-three point five (33.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1070474 herein granted the sum of four hundred (\$400.00) per annum in advance."

Section 2:

This ordinance Amendment shall be in effect upon its passage.
