SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the M2-3 Light Industry District and C1-1 Neighborhood Commercial District symbols and indications as shown on Map 1-G in the area bounded by:

West Carroll Avenue; a line 124.67 feet east of and parallel to North Carpenter Street; a line 129.06 feet south of and parallel to West Carroll Avenue; a line 104.50 feet east of and parallel to North Carpenter Street; a line 166.25 feet south of and parallel to West Carroll Avenue; a line 118.52 feet east of and parallel to North Carpenter Street; a line 192.58 feet south of and parallel to West Carroll Avenue; a line 124.60 feet east of and parallel to North Carpenter Street; West Fulton Street; North Carpenter Street;

to those of a C3-5 Commercial, Manufacturing and Employment District.

The subject property consists of approximately 36,596 square feet and is improved with (i) a two-story building of approximately 14,726 square feet, (ii) a one-story building of approximately 10,980 square feet, (iii) a two-story building of approximately 3,524 square feet, (iv) a three-story building of approximately 8,574 square feet and (v) a one-story building of approximately 13,765 square feet. The property is currently used as a cold storage warehouse. With the exception of the southwest corner of the subject property, the buildings cover the subject property lot-line to lot-line and together contain approximately 51,569 square feet of floor area (an existing FAR of approximately 1.0).

The Applicant, 1K FULTON, LLC, is under contract to purchase the subject property. The Applicant intends to demolish the existing buildings and construct a mixed-use 6-story commercial building, containing approximately 178,156 square feet, for use by office, retail and other uses permitted in the C3-5 district.

The Applicant is seeking to obtain a rezoning from C1-1 and M2-3 to C3-5 to permit the use described above. The proposed rezoning is a "Type I" map amendment within an industrial corridor.

The Applicant expects to start the project in the fourth quarter of 2012 and complete the rehabilitation and begin to open the project for business in the second quarter of 2014.

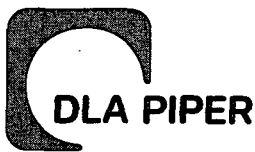

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 6, 2012, the undersigned, on behalf of 1K Fulton, LLC (the "Applicant"), intends to file an application for a change in zoning from Zone C1-1 and Zone M2-3 to Zone C3-5 for the property located at 1022 West Fulton Market, Chicago, Illinois 60607 (the "subject property").

The subject property is bounded by West Carroll Avenue; a line approximately 124.67 feet east of and parallel to North Carpenter Street; a line approximately 129.06 feet south of and parallel to West Carroll Avenue; a line approximately 104.50 feet east of and parallel to North Carpenter Street; a line approximately 166.25 feet south of and parallel to West Carroll Avenue; a line approximately 118.52 feet east of and parallel to North Carpenter Street; a line approximately 192.58 feet south of and parallel to West Carroll Avenue; a line approximately 124.60 feet east of and parallel to North Carpenter Street; West Fulton Street; and North Carpenter Street.

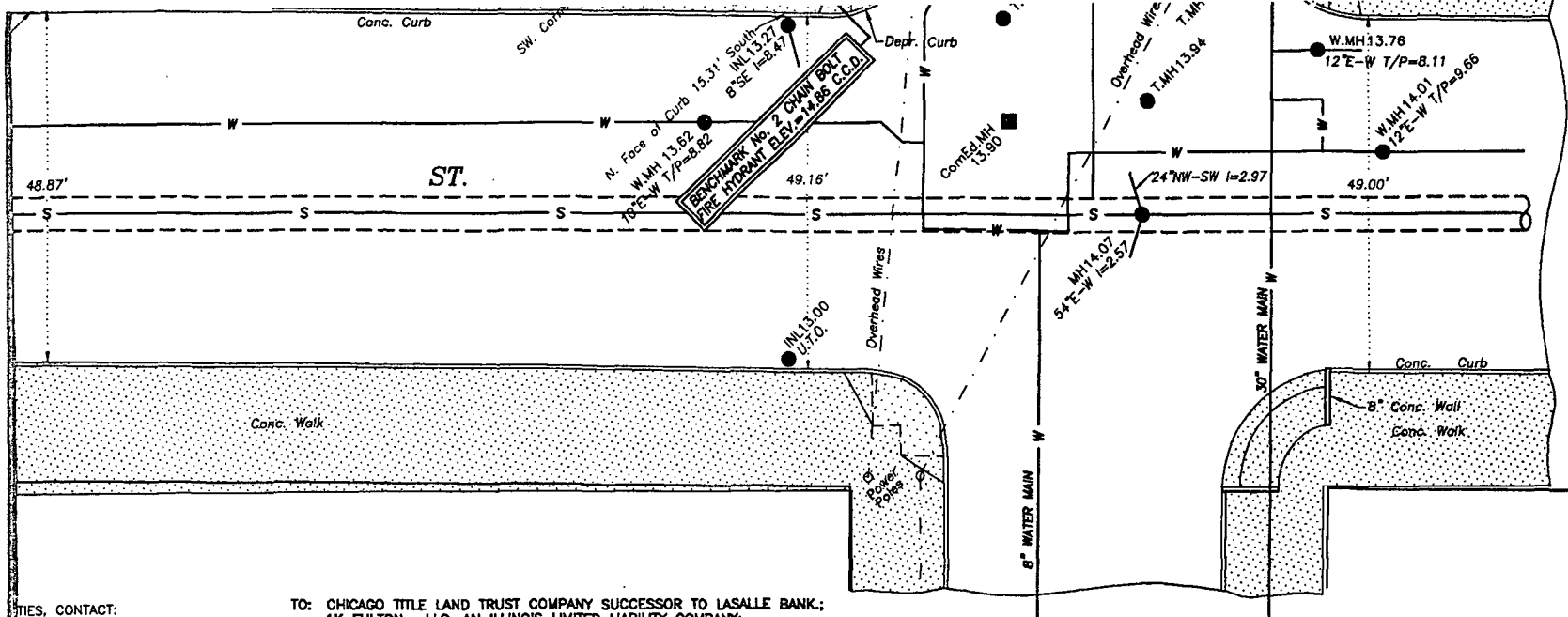

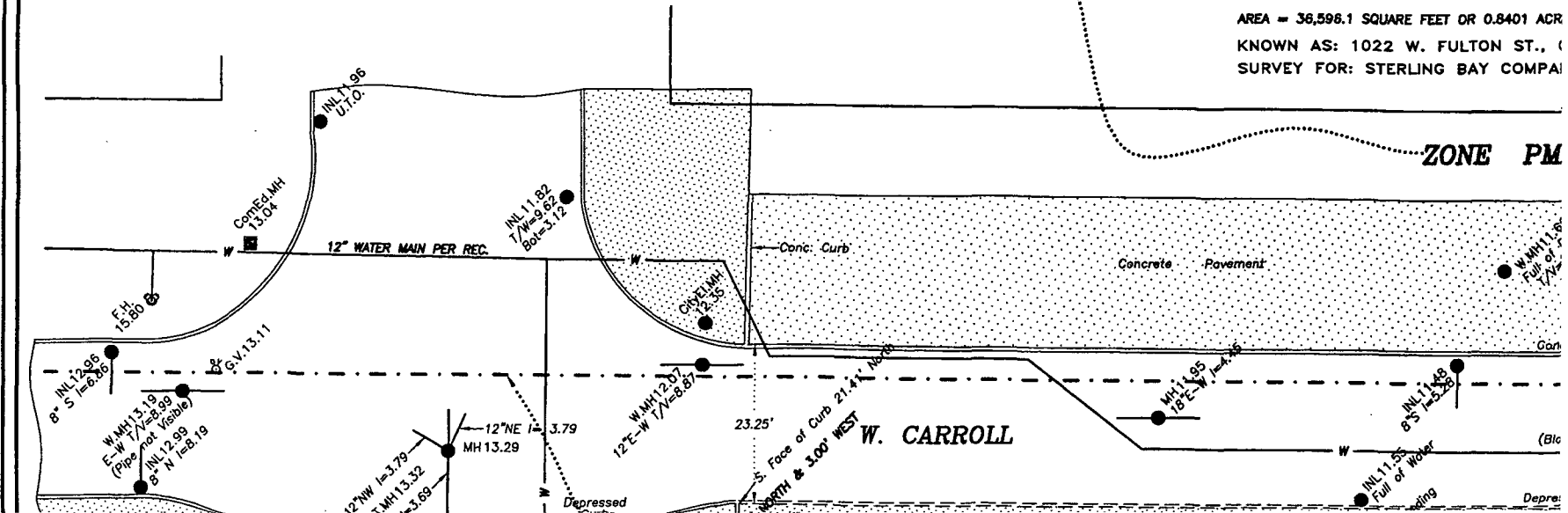
