BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the M1-2, Limited
Manufacturing/Business Park District symbols as shown on Map No. 16-E
in the area bounded by:

A line 175 feet northwest of and parallel to East 69<sup>th</sup> Place; a public alley next northeast of and parallel to south South Chicago Avenue; a line 50 feet northwest of and parallel to east 69<sup>th</sup> Place; south South Chicago Avenue.

To those of a C1-2, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.
