SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 17-I in the area bounded by

The perpendicular public alley to North Troy Street (and next north of and parallel to West Devon Avenue); a line 125 feet long perpendicular to West Devon Avenue (and 107.89 feet east of and parallel to North Troy Street); West Devon Avenue; a line 125 feet long perpendicular to West Devon Avenue (and 57.89 feet east of and parallel to North Troy Street),

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.
