## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago is hereby amended by adding a section 17-9-0119, by adding the language underscored and by deleting the language struck through, as follows:

17-9-0119 Location Restrictions for Certain Retail Food Establishments-Live Poultry.

No retail food establishment that sells live poultry or other live fowl at retail, or that slaughters or causes to be slaughtered for sale live poultry or other fowl at retail, shall be located within 200 feet from any place or structure: (1) in which is located a retail or wholesale food establishment; (2) is used for residential purposes; or (3) is used as a place of religious assembly, primary or secondary school, library, hospital, public park or public playground, measured from property line to property line.

**SECTION 2.** This ordinance takes effect after its passage and publication.
