Reboyras, Ariel (30) Ordinance Grant(s) of privilege in public way for Bim Bom Committee on Transportation and Public Way ORDINANCE BIM BOM Acct. No. 28910 - 1 Permit No. 1101041

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BIM BOM, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Facade(s) projecting over the public right-of-way adjacent to its premises known as 5226 W. Belmont Ave.

Said Facade(s) at W. Belmont Avenue measure(s):

One (1) at twenty-six point nine (26.9) feet in length, and two point eight (2.8) feet in width for a total of seventy-five point three two (75.32) square feet.

One (1) at five point six six (5.66) feet in length, and nine (9) feet in width for a total of fifty point nine four (50.94) square feet.

One (1) at four point nine one (4.91) feet in length, and five point five (5.5) feet in width for a total of twenty-seven point zero one (27.01) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1101041 herein granted the sum of four hundred (\$400.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 05/09/2012.
