ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House) and RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.5-I in the area bounded by

the alley next north of and parallel to West Cortland Street;
North Western Avenue; West Cortland Avenue; and a line
150.80 feet west of and parallel to North Western Avenue,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

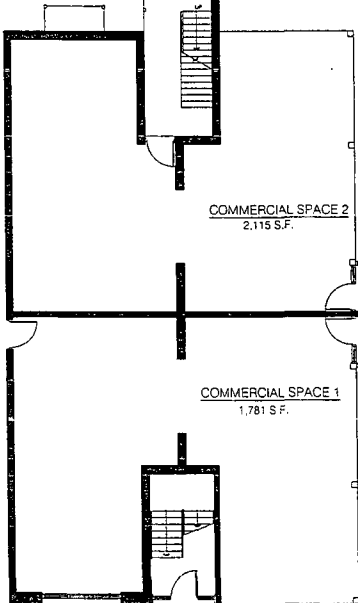

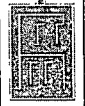


2 ND FLOOR PLAN

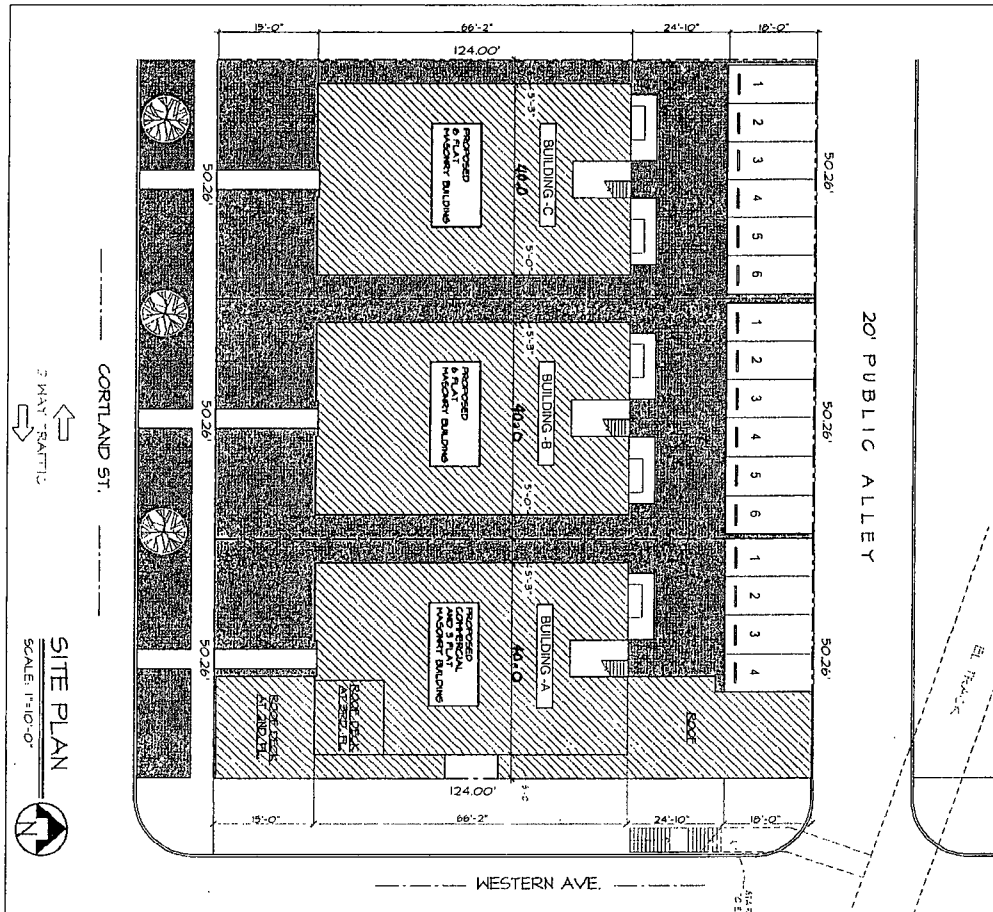
1ST FLOOR PLAN

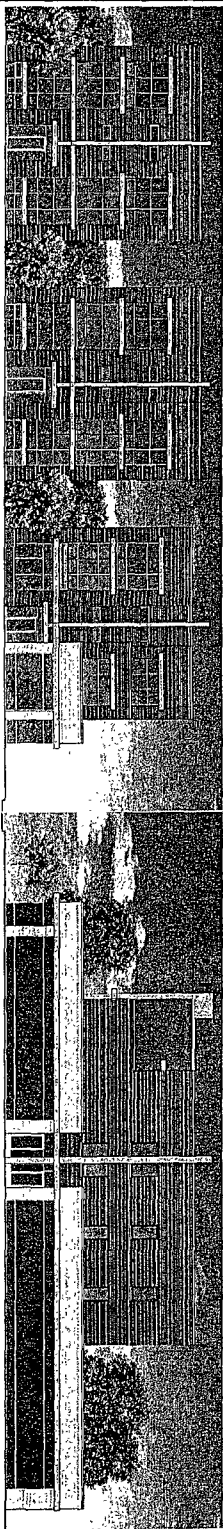
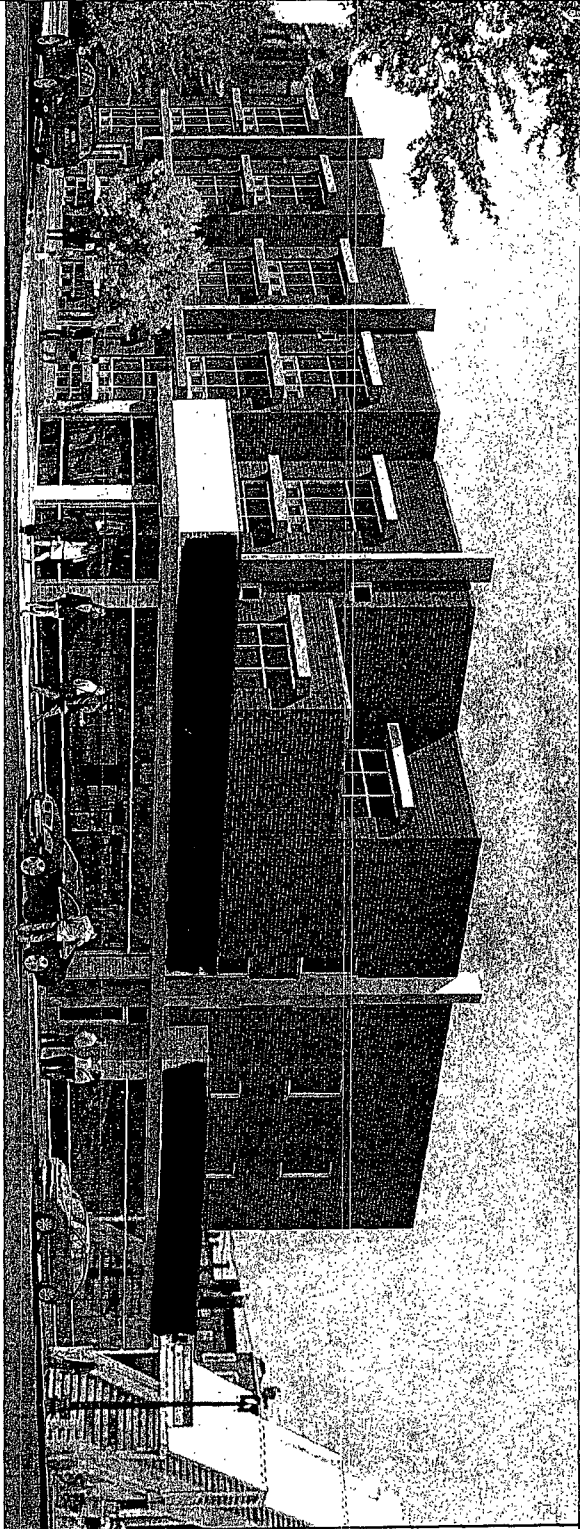
