

The property is currently improved with a one story, brick, commercial building that is approximately 36 years in age. The exterior elevations and footprint of the building will remain unchanged as a result of the subject application. The Amendment is requested in order to expand the existing child day care facility located in the existing building 2839 South Archer Avenue into the existing commercial building at 2841 South Archer Avenue. Both buildings are under common ownership.

The existing one story building at 2841 South Archer Avenue measures approximately 32.23 feet by 80.53 feet for a floor area of 2,596 square feet. The lot measures approximately 32.23 feet by 102 feet resulting in a lot area of 3,288 square feet. The resulting floor area ratio is .79. The building will be used entirely for commercial purposes and will, continue to provide no parking and maintain its existing setbacks as detailed in the attached survey.






