ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Neighborhood Shopping District symbols and indications as shown on Map No. 5-F in the area bounded by

A line 230.55 feet north of and parallel to West Menomonee Street (as measured along the east boundary line of the public alley next west of and parallel to North Wells Street); North Wells Street; a line 150.13 feet north of and parallel to West Menomonee Street (as measured along the east boundary line of the public alley next west of and parallel to North Wells Street); the public alley next west of and parallel to North Wells Street,

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
