#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 7-H in the area bounded

West Diversey Parkway; a line 277.5 feet east of the east boundary line of North Clybourn Avenue (as measured along the south boundary line of West Diversey Parkway); the public alley next northeast of and parallel to North Clybourn Avenue; the public alley next east of North Clybourn Avenue (said public alley being perpendicular to West Diversey Parkway)

to those of a C1-3, Neighborhood Commercial District.

Section 2. This ordinance takes effect after its passage and approval.
