# ORDINANCE

WHEREAS, the City of Chicago (the "City") is a municipal corporation and home rule unit of government under Article VII, Section 6(a) of the 1970 Constitution of the State of Illinois; and

WHEREAS, the Illinois Manufacturing Extension Center, an Illinois not for profit corporation ("IMEC") desires to cooperate with the City, acting through its Department of Housing and Economic Development ("HED"), to assist in implementing the Chicago Sustainable Industries plan; and

WHEREAS, the City and IMEC wish to enter into a grant agreement (a "Grant Agreement") in which (1) IMEC would grant to the City the services of IMEC staff to assist in implementing the Chicago Sustainable Industries plan and other policies and programs of HED, (2) the City would grant to IMEC the services of City staff with a value not to exceed \$150,000 per year (including salary, payroll-related taxes, insurance and fringe benefits) and the use of City equipment and office space by IMEC employees, to support such Chicago Sustainable Industries plan and other policies and programs of HED, and (3) the initial term would be two years, with HED having the option of extending the term for additional two-year periods, for a total term not to exceed ten (10) years (collectively, the "Material Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1**. The above recitals are incorporated herein by this reference.

**SECTION 2.** The Grant Agreement is hereby approved as described above. The Commissioner of HED (the "Commissioner") or a designee of the Commissioner (collectively, an "Authorized Officer"), are each hereby authorized, subject to approval by the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Grant Agreement which do not substantially modify the Material Terms. The Authorized Officer is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements, amendments and instruments, and perform any and all acts as shall be necessary or advisable, in connection with the Grant Agreement which do not substantially modify the Material Terms.

**SECTION 3.** To the extent that any ordinance, resolution, rule, order, or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall be controlling. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

**SECTION 4**. This ordinance takes effect upon passage and approval.
