Amendment of Sections 4-60-022 and 4-60-023 of Municipal Code to disallow additional alcoholic liquor and package good licenses on portion(s) of E 80th St Committee on License and Consumer Protection

ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 and 3 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by Inserting the underscored language as new subsections 4-60-022(7.22) through 4-60-022(7.26), as follows:

4-60-022 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021(c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- (7.26) On 80th Street, from Houston Avenue to Brandon Avenue.

SECTION 3. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023(7.22) through 4-60-023(7.26), as follows:

4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021(c), no additional package goods license shall be issued for any premises located within the following areas:

(7.26) On 80th Street, from Houston Avenue to Brandon Avenue.
