### <u>ORDINANCE</u>

1

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B2-2 Neighborhood Mixed-Use District symbols and indications as shown on Map No.7-J in the area bounded by

North Milwaukee Avenue; a line 180 feet northwest of the intersection of North Milwaukee Avenue and West Diversey Avenue as measured along the southwesterly right-of-way line of North Milwaukee Avenue and perpendicular thereto; a line 181 feet west of the intersection of North Milwaukee Avenue and West Diversey Avenue as measured along the north right-of-way line of West Diversey Avenue and perpenducular thereto; West Diversey Avenue; a line 231 feet west of the intersection of North Milwaukee Avenue and West Diversey Avenue as measured along the north right-of-way line of West Diversey Avenue and perpendicular thereto; and a line 230 feet northwest of the intersection of intersection of North Milwaukee Avenue and West Diversey Avenue as measured along the southwesterly right-of-way line of North Milwaukee Avenue and perpendicular thereto,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
