Amendment of 2012 Annual Appropriation Ordinance within Fund No. 925 for Dept. of Cultural Affairs and Special Events Committee on Budget and Government Operations

Committee(s) Assignment:

#### SUBSTITUTE ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2012 of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the Annual Appropriation Ordinance, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City, through its Department of Cultural Affairs and Special Events ("DCASE") has been awarded private grant funds in the amount of \$5,000 from Coletta and Company Inc. which shall be used for the Summer Dance program; and

WHEREAS, the Chicago Community Trust ("CCT"), on behalf of DCASE, applied to the Boeing Company for private grant funds in the amount of \$30,000 to be awarded to the City and used by DCASE for the In the Works Theatre Lab Series project; and

WHEREAS, CCT, on behalf of DCASE, applied to the Boeing Company for private grant funds in the amount of \$45,000 to be awarded to the City and used by DCASE for the Made in Chicago: World Class Jazz project; and

WHEREAS, the City through its Department of Public Health has been awarded additional federal carryover grant funds in the amount of \$2,598,000 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention which shall be used for the Bioterrorism Preparedness Response Planning program; and

WHEREAS, the City through its Department of Family and Support Services has been awarded additional state grant funds in the amount of \$28,000 by the Illinois Department of Insurance which shall be used for the Senior Health Insurance Program; and

WHEREAS, the City through its Office of Emergency Management and Communications ("OEMC") has been awarded private grant funds in the amount of \$27,000 from Nextel West Corporation (Sprint/Nextel) which shall be used for the Nextel Frequency Reconfiguration project; and

WHEREAS, the City through OEMC has been awarded federal grant funds in the amount of \$7,500,000 by the United States Department of Homeland Security which shall be used for the National Special Security Event Grant Program; now, therefore,

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The sum of \$10,233,000 not previously appropriated is hereby appropriated from Fund 925 - Grant Funds for the year 2012. The Annual Appropriation Ordinance is hereby amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which is hereby made a part hereof.

SECTION 2. The actions by CCT to solicit grant funds on behalf of the City for the "In the Works Theatre Lab Series" and "Made in Chicago: World Class Jazz" projects are hereby ratified and approved.

SECTION 3. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 3. This ordinance shall be in full force and effect upon its passage and approval.
