#### **ORDINANCE**

WHEREAS, the City of Chicago (the "City"), a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, has heretofore found and does hereby find that there exists within the City a serious shortage of decent, safe and sanitary rental housing available to persons of low and moderate income; and

WHEREAS, the City has determined that the continuance of a shortage of affordable rental housing is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City is the owner of the real property commonly known as 6730-6810 South Keating Avenue, Chicago, Illinois, which is legally described on Exhibit A attached hereto (the "Property"); and

WHEREAS, pursuant to the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 et seq., as amended from time to time (the "Act"), and ordinances adopted by the City Council of the City (the "City Council") on October 2, 2002 and published in the Journal of the Proceedings of the City Council of such date at pages 94203 through 94270, the City Council approved a tax increment financing redevelopment plan and project (the "Plan") for the 67<sup>th</sup>/Cicero Redevelopment Project Area (the "Area"), designated the Area as a redevelopment project area under the Act, and adopted tax increment financing under the Act for the Area; and

WHEREAS, the Property is located in the Area; and

WHEREAS, Senior Suites Chicago Midway Village, LLC, is an Illinois limited liability company (the "Developer"), of which Senior Suites Chicago Corporation, an Illinois corporation, is the sole member, and whose offices are located at 111 East Wacker Drive, Suite 2200, Chicago, Illinois, 60601; and

WHEREAS, the Developer desires to purchase the Property from the City for its appraised value of One Million One Hundred Thousand and No/100 Dollars (\$1,100,000.00) and thereafter construct thereon a five story building containing eighty-nine (89) affordable rental units for independent seniors age 62 and over (the "Project"); and

WHEREAS, by Resolution No. 10-CDC-71, adopted on November 9, 2010, the Community Development Commission authorized the Department of Housing and Economic Development ("DHED") to advertise its intention to enter into a negotiated sale with the Developer for the redevelopment of the Property consistent with the Plan, and approved DHED's request to advertise for alternative proposals; and

WHEREAS, public notices advertising DHED's intent to enter into a negotiated sale of the Property with the Developer and requesting alternative proposals appeared in the Chicago Sun-Times on November 26, December 2, 2010 and December 16, 2010; and

WHEREAS, no alternative proposals were received by the deadline indicated in the aforesaid notices; and

WHEREAS, the City has certain funds available from a variety of funding sources ("Multi-Family Program Funds") to make loans and grants for the development of multi-family residential housing to increase the number of families served with decent, safe, sanitary and affordable housing and to expand the long-term supply of affordable housing, and such Multi-Family Program Funds are administered by DHED; and

WHEREAS, DHED has preliminarily reviewed and approved the making of a loan to the Developer in an amount not to exceed \$3,007,946 (the "Loan"), to be funded from Multi-Family Program Funds pursuant to the terms and conditions set forth in Exhibit B attached hereto and made a part hereof; now, therefore,

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. Upon the approval and availability of the Additional Financing as shown in Exhibit B hereto, the Commissioner of DHED (the "Commissioner") and a designee of the Commissioner (collectively, the "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Loan. The Authorized Officer is hereby authorized, subject to the approval of the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Loan which do not substantially modify the terms described in Exhibit B hereto. Upon the execution and receipt of proper documentation, the Authorized Officer is hereby authorized to disburse the proceeds of the Loan to the Developer.

SECTION 3. The Project (as described in Exhibit B hereto) shall be deemed to qualify as "Affordable Housing" for purposes of Chapter 16-18 of the Municipal Code of Chicago. Section 2-45-110 of the Municipal Code of Chicago shall not apply to the Project or the Property.

SECTION 4. The sale of the Property to the Developer for the fair market value amount of One Million One Hundred Thousand and No/100 Dollars (\$1,100,000.00) is hereby approved.

SECTION 5. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the Property to the Developer.

(i) Such deed shall state that the City makes no covenant, representation or warranty as to the soil or environmental condition of the Property or the suitability of the Property for any purpose whatsoever, and the Developer agrees to accept the Property "as is". If after the closing of the City's conveyance of the Property to the Developer, the soil or environmental condition of the Property is not in all respects entirely suitable for the use to which the Property is to be utilized, it shall be the sole responsibility and obligation of the Developer to take such action as is necessary to put the Property in a condition suitable for such intended use. The Developer agrees to release and indemnify the City from any claims and liabilities relating to or arising from the environmental condition of the Property (including, without limitation, claims under CERCLA) and to undertake and discharge all liabilities of the City arising from any environmental condition which existed on the Property prior to the closing.

(ii) The Authorized Officer is authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the cancellation of any indebtedness currently secured by a mortgage or similar instrument on the Property and the release of any such mortgage or similar instrument.

SECTION 6. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 7. This ordinance shall take effect immediately upon its passage and approval.

#### Exhibit 1

Senior Suites of Midway Village is designed to provide a functional, comfortable, living atmosphere in an efficient manner. This five story, 77,120 s.f., 89 unit, L-shaped building is intended to become LEED certified, and will be located at 6800 S. Keating Avenue in Chicago. The 84,139 s.f. vacant site is the final phase of the larger 67th/Cicero Redevelopment Area (which already includes a new elementary school, a redeveloped park district property, a 126 unit Independent and Assisted Living seniors housing community, and 24 for-sale condominium units for seniors 55+).

The newly constructed building's structure will be poured in place concrete. Its masonry exterior and mansard roof accenting the parapet wall atop the building are intended to echo the style of the existing residential buildings on campus. Once constructed, Senior Sultes of Midway Village will provide affordable, high quality housing with specially designed amenities and a variety of personal services appealing to the needs and desires of senior citizens. Planned social activities, transportation, and monthly housekeeping are among the services included in the Senior Sultes service program within LIHTC and HOME eligible rents.

Intended to promote a socially stimulating atmosphere, each building contains approximately 5,500 square feet of common area for use by the residents. The focal point is a 2,500 square foot main floor Club-Lounge which includes a library, community room, and dining facilities. Additional lounge areas providing a variety of amenities including comfortable seating, game tables, fitness equipment, television sets, library, and a computer lab can be found throughout the building. Free laundry facilities are also conveniently located within the community.

The 89 apartments include a mix of 1BR, 2BR, and studio apartments. Each apartment is designed specifically for the elderly and is equipped with a full kitchen, spacious bath, carpeting, window coverings, individually controlled heat, and air conditioning. Design features include kitchen cabinets that are easily accessible and safe and easy to operate appliances. In addition, grab bars are provided in the bathrooms to accommodate the needs of seniors, bathroom doors swing out to facilitate emergency access, and emergency-pull-cords are located in the bathroom and bedroom of each apartment. Easy to turn lever door handles are featured throughout the community. Electrical outlets have been raised to minimize the need to bend over and light switches are lowered to be more accessible. An added measure of security is provided by an Up-and-About system that allows residents to check-in with management each morning.

#### Exhibit 1

Senior Suites of Midway Village is designed to provide a functional, comfortable, living atmosphere in an efficient manner. This five story, 77,120 s.f., 89 unit, L-shaped building is intended to become LEED certified, and will be located at 6800 S. Keating Avenue in Chicago. The 84,139 s.f. vacant site is the final phase of the larger 67th/Cicero Redevelopment Area (which already includes a new elementary school, a redeveloped park district property, a 126 unit Independent and Assisted Living seniors housing community, and 24 for-sale condominium units for seniors 55+).

The newly constructed building's structure will be poured in place concrete. Its masonry exterior and mansard roof accenting the parapet wall atop the building are intended to echo the style of the existing residential buildings on campus. Once constructed, Senior Suites of Midway Village will provide affordable, high quality housing with specially designed amenities and a variety of personal services appealing to the needs and desires of senior citizens. Planned social activities, transportation, and monthly housekeeping are among the services included in the Senior Suites service program within LIHTC and HOME eligible rents.

Intended to promote a socially stimulating atmosphere, each building contains approximately 5,500 square feet of common area for use by the residents. The focal point is a 2,500 square foot main floor Club-Lounge which includes a library, community room, and dining facilities. Additional lounge areas providing a variety of amenities including comfortable seating, game tables, fitness equipment, television sets, library, and a computer lab can be found throughout the building. Free laundry facilities are also conveniently located within the community.

The 89 apartments include a mix of 1BR, 2BR, and studio apartments. Each apartment is designed specifically for the elderly and is equipped with a full kitchen, spacious bath, carpeting, window coverings, individually controlled heat, and air conditioning. Design features include kitchen cabinets that are easily accessible and safe and easy to operate appliances. In addition, grab bars are provided in the bathrooms to accommodate the needs of seniors, bathroom doors swing out to facilitate emergency access, and emergency-pull-cords are located in the bathroom and bedroom of each apartment. Easy to turn lever door handles are featured throughout the community. Electrical outlets have been raised to minimize the need to bend over and light switches are lowered to be more accessible. An added measure of security is provided by an Up-and-About system that allows residents to check-in with management each morning.


