#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 19-G in the area bounded by

A line 156 feet south of and parallel to West Fargo Avenue(as measured along the northeast boundary line of North Sheridan Road); the public alley next northeast of and parallel to North Sheridan Road; a line 261 feet south of and parallel to West Fargo Avenue (as measured along the northeast boundary line of North Sheridan Road); North Sheridan Road,

to those of a B2-1 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.
