BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit
(Detached House) District symbols and indications as shown on Map No. 11-M in area bound by

West Montrose Avenue; a line 24.87 feet west of and parallel to North Meade Avenue; the alley next south of and parallel to West Montrose Avenue; and a line 54.77 feet west of and parallel to North Meade Avenue,

to those of a B1-1 Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.


