<u>ORDINANCE</u>

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No.9-H in the area bounded by

West Irving Park Road; North Hoyne Avenue; the alley next south of and parallel to West Irving Park Road; and a line 144.25 feet west of and parallel to North Hoyne Avenue,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Each of the two all residential buildings will contain six (6) dwelling units and detached garage parking for six vehicles at the rear of the building (along a Private Alley within the west lot line).






