West Ancona Street; a line 168.00 feet east of North Noble Street; a line 59.00 feet north of West Erie Street; a line 216.00 feet east of North Noble Street; West Erie Street; and a line 144.00 feet east of North Noble Street

to those of a B2-3 Neighborhood Mixed-Use District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

The subject property contains approximately 5,688 sq. ft. of land of which approximately 2,880 is contained in two unimproved lots of record, one fronting on W. Ancona Street and the other comprising the eastern portion of the subject property. The balance of the property is improved with a tall 2.5 story building containing a total of approximately 7,220 sq. ft. The building was originally constructed for use, and used as a church. For over a decade it has been used for offices, including the current use for that purpose by the Applicant. The Applicant uses the building for its offices in connection with its business producing advertising to be displayed over the Internet. The building is constructed on two lots of record and, with respect to those lots, built to the property lines. There is no parking or loading on the property. The Applicant seeks the rezoning to permit the office use of the property and to otherwise bring the bulk of the property into conformance with the zoning regulations. No construction is proposed at this time. The two vacant parcels are intended to remain vacant. Given the size of the office use, the B2-3 district is required because of the parking requirements that would otherwise apply to the office use.
