INDUSTRIAL ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City has experienced a significant loss of industry and jobs in recent years, accompanied by a corresponding erosion of its tax base, due in part to industrial firms' inability to acquire additional property needed for their continued viability and growth; and

WHEREAS, many industrial firms adjoin streets and alleys that are no longer required for public use and might more productively be used for plant expansion and modernization, employee parking, improved security, truck loading areas or other industrial uses; and

WHEREAS, the City can strengthen established industrial areas and expand the city's jobs base by encouraging the growth and modernization of existing industrial facilities through the vacation of public streets and alleys for reduced compensation; and

WHEREAS, the properties at 839 - 845 W. 22nd Place & 834 - 846 W. 23rd Street are owned by Phillip Mumford, the owner of Colonial Brick; and

WHEREAS, Colonial Brick employs 7 full time employees; and

WHEREAS, Phillip Mumford proposes to use the portion of the Alley to be vacated herein for the parking of Colonial Brick's commercial vehicles, visitor parking, truck routing and storage of materials; and

WHEREAS, The City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of public use and the public interest to be subserved is such as to warrant the vacation of part of the public Alley described in the following ordinance; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. ALL THAT PART OF THE 20.0 FOOT WIDE PUBLIC ALLEY LYING IN BLOCK 2 IN MRS. BRIDGET O'NEIL'S SUBDIVISION, IN THE NORTHEAST FRACTIONAL QUARTER OF SECTION 29, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JANUARY 7, 1867 ANTE FIRE, RE-RECORDED NOVEMBER 22, 1888 AS DOCUMENT

NUMBER 1031669 AND ALSO LYING IN BLOCK 2 IN REV. A. DAMON'S SUBDIVISION RECORDED ANTE-FIRE IN THE NORTHEAST FRACTIONAL QUARTER OF SECTION 29, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED BY BEGINNING AT THE SOUTHEAST CORNER OF LOT 4 IN BLOCK 2 IN SAID MRS. BRIDGET O'NEIL SUBDIVISION THENCE SOUTHERLY, ALONG THE WEST LINE OF VACATION ORDINANCE DOCUMENT RECORDED MAY 10, 2012 AS DOCUMENT NUMBER 1213134122, 20.0 FEET TO THE NORTHEAST CORNER OF LOT 11 IN BLOCK 2 IN MRS BRIDGET O'NEIL SUBDIVISION, THENCE WESTERLY, ALONG THE NORTH LINE OF LOTS 11, 10, 9, 8, 7 AND 6 IN SAID BLOCK 2 IN MRS BRIDGET O'NEIL SUBDIVISION TO THE NORTHWEST CORNER OF SAID LOT 6 IN BLOCK 2; THENCE NORTHERLY, ALONG THE EASTERLY LINE OF VACATION ORDINANCE DOCUMENT RECORDED SEPTEMBER 23, 2005 AS DOCUMENT NUMBER 0526627004, 20.0 FEET TO THE SOUTHWEST CORNER OF LOT 4 IN BLOCK 2 IN REV. A. DAMON'S SUBDIVISION; THENCE EASTERLY, ALONG THE SOUTH LINE OF LOTS 4, 3, 2 AND 1 IN SAID BLOCK 2 IN REV. A. DAMON'S SUBDIVISION AND THE SOUTH LINE OF LOTS 5 AND 4 IN SAID BLOCK 2 IN MRS. BRIDGET O'NEIL SUBDIVISION, TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS, as shaded and legally described by the words "HEREBY VACATED" on the Plat hereto attached as Exhibit A, which drawing for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The Commissioner of Transportation is hereby authorized to accept and approve a restrictive covenant or similar instrument restricting the use and improvement of the public way vacated in Section 1 of this ordinance to industrial uses and for such use and improvements that are accessory as that term is defined in the Chicago Zoning Ordinance. The restriction on use and improvement in the covenant agreement or instrument shall be for a term of 40 years and upon breach of such restriction the public way herein vacated shall revert to the City and be subject to the terms and conditions of the dedication by which it has been heretofore held by the City.

SECTION 3. The City of Chicago hereby reserves for the benefit of Commonwealth Edison its successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the alley herein vacated, with the right of ingress and egress. The grade of the vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of Commonwealth Edison's facilities. No buildings, permanent structures or obstructions shall be placed over Commonwealth Edison's facilities without written release of easement by Commonwealth Edison. Any future relocation of Commonwealth Edison's facilities lying within the area being vacated will be done by Commonwealth Edison

SECTION 4. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Phillip Mumford shall pay or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with a restrictive covenant, complying with Section 2 of this ordinance and approved by the Corporation Counsel, and the attached Plat of Vacation.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication.


