PLANNED DEVELOPMENT STATEMENTS

- The area delineated herein as Business Planned Development Number 699, as amended, (Planned Development) consists of approximately 898,333 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map (Property) and is owned by North and Cicero Development LLC. For the purposes of this Application, the Applicant, Ralphs Grocery Company (d/b/a Food 4 Less Midwest), controls that portion of the Property that it currently leases from the Owner.
- 2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Sec 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Sec 17-8-0400 of the Zoning Ordinance.
- 3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees. Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans. Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of the Department of Transportation. All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.
- 4. This Plan of Development consists of 15 Statements: a Bulk Regulations Table; a Planned Development Aerial Map, an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; an Overall Site Plan; a New Fuel Center Site Plan; and Fuel Center Elevations prepared by Corporate Design + Development Group, LLC and dated December 20, 2102; a Landscape Plan prepared by Brusseau Design Group, LLC and dated December 20, 2012; Building Elevations prepared by Keystone Structures, Inc. and dated December 20,2012; and a Chicago Builds Green form prepared by Corporate Design + Development Group, LLC and dated December 20,2012; and a Chicago Builds Green form prepared by Corporate Design + Development Group, LLC and dated December 20, 2102, submitted herein. Full-sized copies of the Site Plans, Landscape Plan and Building Elevations are on file with the Department of Housing and Economic Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning

Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

- 5. The following uses are permitted in the area delineated herein as a Planned Development: all uses permitted in a B5-1 Restricted Service District including fuel centers, retail drug stores with drive-through, accessory parking and related uses. The following uses shall be prohibited: residential, hotels, motels, video arcades, stand alone liquor stores or adult uses.
- 6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Development of Housing and Economic Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
- 7. For purposes of height measurement, the definitions of the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
- 8. The maximum permitted Floor Area Ratio (FAR) for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 749,769 square feet.
- 9. Upon review and determination, "Part II Review", pursuant to Sec. 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
- 10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Any interim reviews associated with site plan review or Part II review, are conditional until final Part II approval.
- 11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Sec. 13-32-125 of the Municipal Code, or any other provision of that Code.
- 12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Sec. 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
- 13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout

the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.

- 14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources.
- 15. This Planned Development shall be governed by Sec. 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Housing and Economic Development shall initiate a Zoning Map Amendment to rezone the property to Business Planned Development 699.

PROJECT NARRATIVE

Ralphs Grocery Company (d/b/a Food 4 Less Midwest) is seeking to amend Business Planned Development 699 which governs the Washington Square Shopping Center located at 4821 W. North Avenue in Chicago, Illinois ("Property"). The subject Property has a net site area of 749,769 s.f.

Existing Use: Currently, the property is occupied by the shopping center which is anchored by a Food 4 Less grocery store. There is a mix of other retail uses provided on-site. Planned Development 699 authorizes a maximum FAR of .30; the existing FAR is .274. Planned Development 699 further provides that a minimum of 860 parking spaces and 4 loading docks are to be provided on site; there are currently 845 parking spaces and 7 loading docks present on site. The terms of the Planned Development specifically prohibit the location of an auto service station on the Property.

<u>Proposed Use:</u> The Property will continue to be occupied by a shopping center which is anchored by a Food 4 Less grocery store. All existing buildings and uses will be unaffected by the amended planned development ordinance. The amendment to the planned development is required to allow the location of a fuel center on the Property and to reduce the amount of parking required on site. The provisions of the Planned Development, as amended, shall continue to authorize a maximum FAR of .30; the proposed FAR shall be .278. The minimum number of parking spaces required shall be lowered to 785 spaces. The fuel center shall be fully landscaped to enhance the aesthetics of the existing parking lot.





Transportation The proposed fuel center will be located on a parcel that is currently occupied by a shopping center. All required parking for the fuel center will be provided and is currently existing in the shopping center.

Landscaping

The planned development is deficient in all landscape categories in its existing state. During the project's initial landscape review with Ron Daye, he issued a preliminary recommendation of adding 11 trees to the project site given that the entire PD was deficient. Our current landscape plans indicate the addition of 11 trees per Ron Dayes recommendation. In total the project will remove 7 trees and replace them with 11. The fuel center will not bring the PD into full landscape compliance, but will provide more landscape features than is currently present.
