ORDINANCE

WHEREAS, as a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, the City of Chicago (the "City") has the power to regulate for the protection of the public health, safety, morals and welfare of its inhabitants; and

WHEREAS, SOS Children's Villages, Illinois, an Illinois not-for-profit corporation (or an affiliate thereof) (the "Grantee") intends to (1) acquire some or all of the properties located at 7612, 7619 and 7620 South Parnell Avenue, Chicago, Illinois 60620, and/or other properties also located in Residential-Business Planned Development Number 849 (collectively or any subset thereof, the "Rehabilitation Property"), and rehabilitate the existing buildings thereon and operate the rehabilitated buildings as foster care facilities (collectively the "Rehabilitation Facility") thereon (the acquisition and rehabilitation of the Rehabilitation Facility on the Rehabilitation Property shall be known herein as the "Rehabilitation Project"), and/or (2) construct and operate multi-unit foster care facilities (collectively the "Construction Facility") on the properties located at 7654, 7656 and 7655 South Parnell Avenue, Chicago, Illinois 60620 (collectively or any subset thereof, the "Construction Property") (the construction of the Construction Facility on the Construction Property shall be known herein as the "Construction Project") (the Rehabilitation Project, the Construction Project or some combination thereof, as determined by the hereinafter defined Authorized Officer pursuant to Section 2 hereof, shall be known herein as the "Project"); and

WHEREAS, the City agrees to grant an amount not to exceed \$800,000 (the "Grant") to the Grantee for the costs of the Project; and

WHEREAS, the Grant shall be funded from a portion of the proceeds of its \$547,590 General Obligation Bonds Project and Refunding Series 2007A (the "2007 Bonds") issued pursuant to an ordinance adopted by the City Council on April 11, 2007 and published at pages 101765 through 101804 in the Journal of the Proceedings of the City Council (the "Journal") of such date (the "2007 Bond Ordinance") and its \$388,001,650 General Obligation Bonds Project and Refunding Series 2008C (together with the 2007 Bonds, the "Bonds") issued pursuant to an ordinance adopted by the City Council on May 5, 2008 and published at pages 42735 through 42769 in the Journal of such date (together with the 2007 Bond Ordinance, the "Bond Ordinance"); and

WHEREAS, pursuant to the Bond Ordinance, the proceeds of the Bonds may be used to finance, among other things, grants to not-for-profit or for-profit organizations doing business or seeking to do business in the City for the purpose of the enhancement of economic development within the City; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Commissioner of HED (the "Commissioner") and a designee of the Commissioner (collectively, the "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Grant. The Authorized Officer is authorized to determine whether the

Rehabilitation Project, the Construction Project or some combination thereof shall be the Project for purposes of the Grant. The Authorized Officer is hereby authorized, subject to the approval of the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Grant which do not substantially modify the terms of the Grant described herein. Upon the execution and receipt of proper documentation, the Authorized Officer is hereby authorized to disburse the proceeds of the Grant to the Grantee.

SECTION 3. Section 2-45-110 of the Municipal Code of Chicago shall not apply to the Project or the Property.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.

C. If the City determines that any information provided in this EDS is false, incomplete or inaccurate, any contract or other agreement in connection with which it is submitted may be rescinded or be void or voidable, and the City may pursue any remedies under the contract or agreement (if not rescinded or void), at law, or in equity, including terminating the Disclosing Party's participation in the Matter and/or declining to allow the Disclosing Party to participate in other transactions with the City. Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.

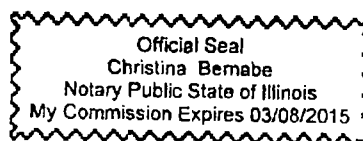
