BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance

be amended by changing all the B3-1, Community Shopping District symbols and indications as shown on Map No. 16-E in the area bounded by:

South Indiana Avenue; East Marquette Road; the north/south public alley next west of and parallel to South Indiana Avenue; and a line 75.00 feet north of and parallel to East Marquette Road,

to those of a RM5.5, Residential Multi-Unit District which is hereby established in the area described and a corresponding use district.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements of Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about March 13, 2013, Christian Heritage Training Center, as the 100% beneficial owner of Chicago Title Land Trust Agreement dated March 25, 1993, known as Trust Number 116772-00 will file an application to change the zoning for the property commonly known as 146-160 East Marquette Road and 6664-6670 South Indiana Avenue (the "Property") from its current zoning designation of B3-1, Community Shopping District to RM5.5, Residential Multi-Unit District.
