*Be It Ordained by the City Council of the City of Chicago:*

Permission and authority are hereby given and granted to STICKY RICE upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 4018 N. Western Ave.. Said sidewalk cafe area #1 shall be twenty-three point five (23.5) feet in length and eight (8) feet in width for a total of one hundred eighty-eight (188) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along N. Western Avenue. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Thursday 11:30am until 10:00pm Friday and Saturday 11:30am until 11:00pm Sunday 12:00 Noon until 10:00 p.m.

Compensation: \$600.00




