Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MADEWELL, INC, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 932 N. Rush St..

Said sign structure(s) measures as follows; along N. Rush:

One (1) at six point three three (6.33) feet in length, one point five (1.5) feet in height and sixteen (16) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1104581 herein granted the sum of one hundred (\$100.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.



- 2 LETTER RETURNS & FACES ARE WELDED TOGETHER AROUND THE ENTIRE PERIMETER OF LETTER
- 3 'SLOAN MINI' 6500K WHITE LED UNITS TO ILLUMINATE LETTERS
- 4 1/8" THICK, "SATIN ICE" ACRYLIC LETTER BACKS
- 5 ELECTRICAL WIRING FOR LED'S THRU ELECTRICAL CONDUIT
- 6 .090 ROUTED ALUMINUM LETTER FACES PAINTED TO MATCH BM #2061-10 "DEEP ROYAL"
- 7 ALL INTERIOR LETTER SURFACES ARE PAINTED HIGH GLOSS WHITE
- 8 1" PLASTIC SPACERS ARE RIV NUTTED INTO ACRYLIC LETTER BACKS, ALL THREAD ROD WILL SCREW INTO RIV NUTS, 10-24 NUT BEHIND WALL TO LOCK ALL THREAD ROD INTO PLACE
- 9 1/2" RIGID CONDUIT THRU WALL SECTION
- 10 LED WIRING TO PRIMARY ELECTRICAL SOURCE & SERVICE DISCONNECT SWITCH (BY OTHERS) AND TO REMOTELY LOCATED LED POWER SUPPLIES (FIELD CONDITIONS TO DETERMINE EXACT LOCATION)
- 11 CLIPS ARE POP-RIVETED INTO ACRYLIC LETTER BACKS, AND THE BACKS ARE SECURED TO THE LETTER RETURNS WITH SELF TAPPING SCREWS THRU THE LETTER RETURNS
