Townhouse and Multi-Unit District symbols as shown on Map No. 16-F
in the area bounded by:

West 66th Street; the public alley next East of and parallel to South Lowe Avenue; a line 30 feet South of and parallel to west 66th Street; South Lowe Avenue.

To those of a B2-2, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and approval.
