Said Light Fixture(s) at 335 E. 35th Street measure(s): Four (4) at one (1) foot in length, one (1) foot in width and eighteen (18) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

The grantee shall pay to the City of Chicago as compensation for the privilege #1105419 herein granted the sum of ninety (\$90.00) per annum in advance.


