Amendment of Year 2013 Annual Appropriation Ordinance within Fund No. 925 for Dept. of Transportation Committee on Budget and Government Operations

SUBSTITUTE ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2013 of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the Annual Appropriation Ordinance, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City through its Department of Innovation and Technology has been awarded private grant funds in the amount of \$1,000,000 from The Bloomberg Family Foundation Inc. which shall be used for the Bloomberg Foundation Challenge Grant Smart Data Platform Program; and

WHEREAS, the City through its Department of Cultural Affairs and Special Events ("DCASE") has been awarded additional private grant funds in the amount of \$15,000 by the National Endowment of the Arts which shall be used for a series of free concerts for the Loops and Variations Concerts Program; and

WHEREAS, the City through DCASE has been awarded private grant funds in the amount of \$610,000 by the Public Art Endowment which shall be used for the Public Arts Endowment Program; and

WHEREAS, the City through its Department of Family and Support Services has been awarded federal grant funds in the amount of \$12,000 by the Illinois Department on Aging which shall be used for the Aging and Disability Resource Center Options Program; and

WHEREAS, the City through its Department of Transportation ("CDOT") has been awarded additional state grant funds in the amount of \$6,000,000 by the Illinois Department of Transportation ("IDOT") which shall be used for the IDOT Funds Program; and

WHEREAS, the City through CDOT has been awarded additional federal grant funds In the amount of \$73,000 by the Chicago Transit Authority which shall be used for the Chicago Bike Sharing Program; and

WHEREAS, the City through CDOT has been awarded additional state grant funds in the amount of \$2,001,000 by the Illinois Commerce Commission's Grade Crossing Protection Fund which shall be used for the Vertical Clearance Protection Program; and

WHEREAS, the City through has been awarded additional federal grant funds in the amount of \$1,050,000 from the United States Federal Highway Administration ("USFHA") which shall be used for the construction phase of the Surface Transportation Program (the "STP"); and

WHEREAS, the City through CDOT has been awarded additional state grant funds in the amount of \$263,000 by IDOT which shall be used for the construction phase of the STP; and

WHEREAS, the City through CDOT has been awarded additional federal grant funds in the amount of \$6,009,000 by the USFHA which shall be used for the engineering phase of the STP; and

WHEREAS, the City through CDOT has been awarded private grant funds in the amount of \$16,500,000 by The Trust for Public Land which shall be used for The 606 Park and Trail project; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The sum of \$33,533,000 not previously appropriated, representing increased grant awards is hereby appropriated from Fund 925 - Grant Funds for the year 2013. The Annual Appropriation Ordinance is hereby amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which is hereby made a part hereof.

SECTION 2. The Chief Information Officer of the City is hereby authorized to enter into an agreement, upon such terms and conditions that he or she determines are appropriate with Carnegie Mellon University ("CMU") or an affiliate thereof, for the provision of certain services, by CMU or its affiliate, for the amount of \$600,000 which shall be paid directly by The Bloomberg Family Foundation Inc. to CMU or its affiliate with respect to the Smart Data Platform Program.

SECTION 3. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 4. This ordinance shall be in full force and effect upon its passage and approval.
