## **ORDINANCE**

**WHEREAS**, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City is the owner of the vacant parcel of property located at 6200-6216 South Kenwood Avenue, Chicago, Illinois, which is legally described on Exhibit A attached hereto ("Property"), and which Property is located in the Woodlawn Redevelopment Project Area ("Area") established pursuant to ordinances adopted by the City Council of the City ("City Council") on January 20, 1999, published in the Journal of Proceedings of the City Council ("Journal") for such date at pages 87763 through 87861; and

**WHEREAS**, the City, acting through its Department of Housing and Economic Development ("DHED"), has proposed to sell the Property through a sealed bid auction pursuant to Chapter 2-158 of the Municipal Code of the City of Chicago; and

**WHEREAS**, pursuant to Resolution No. 13-032-21 adopted on June 20, 2013, by the Plan Commission of the City (the "Commission"), the Commission approved the proposed sale of the Property; and

**WHEREAS**, the Commissioner of DHED caused to be published notice advertising the City's intent to sell the Property through a sealed bid auction and such advertisements appeared in the *Chicago Sun-Times*, a newspaper of general circulation, on March 22 and 29, and April 5, 2013; and

**WHEREAS**, the appraised fair market value of the Property, at its highest and best use as of February 28, 2013, is \$39,500; and

**WHEREAS**, the bids received in response to aforesaid the public notice were opened in a public meeting before a certified court reporter and DHED received the following conforming sealed bids: Greenline Development, Incorporated, in the amount of \$31,600.00; David M. Fleishman, in the amount of \$121,000.00; and Fadia N. Tadros, in the amount of \$126,200.00; and

**WHEREAS**, DHED has recommended that the sealed bid of Fadia N. Tadros, the highest bidder, be accepted by the City Council; now, therefore,

### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The City Council hereby accepts the bid of Fadia N. Tadros, 10437 Laporte, Oak Lawn, Illinois 60453 ("Grantee"), and approves the sale of the Property to the Grantee in the amount of One Hundred Twenty-six Thousand Two Hundred and No/100 Dollars (\$126,200.00).

**SECTION 2.** The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the Property to the Grantee, or to a land trust of which the Grantee is the sole beneficiary, or to a business entity of which the Grantee is the sole controlling party. Such deed shall include a covenant obligating

the Grantee to use the Property only for a use consistent with the land uses permitted under the redevelopment plan for the Area.

**SECTION 3.** DHED is authorized to deliver the deed to the Grantee upon receipt of the balance of the purchase price in accordance with its standard procedures. In the event that the closing has not occurred within one hundred twenty (120) days following the passage of this ordinance through no fault of the City, DHED may cancel the proposed sale upon written notice to the Grantee and retain the Grantee's deposit check as liquidated damages.

**SECTION 4.** If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

**SECTION 5.** All ordinances, resolutions, motions or orders inconsistent with this ordinance are hereby repealed or amended to the extent of such conflict.

**SECTION 6.** This ordinance shall take effect upon its passage and approval.

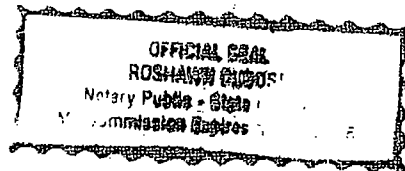
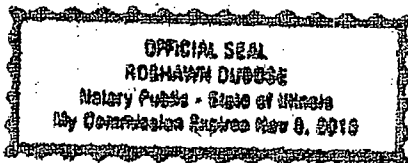
