# ORDINANCE

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.3-G in the area bounded by

West Fry Street; a line 154.62 feet east of and parallel to North Ashland Avenue; the alley next south of and parallel to West Fry Street; and a line 129.56 feet east of and parallel to North Ashland Avenue,

to those of a RT4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.

The proposed new building will contain one duplex unit (between the basement and 1<sup>st</sup> floor) and one simplex unit on, each, the 2<sup>nd</sup> and 3<sup>rd</sup> floors, respectively. The proposed new building will provide porches off the rear of each of the dwelling units (at the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> floors), as well as a communal rooftop deck. There will also be a detached, three-car garage, with rooftop deck, at the rear of the lot. The proposed building will be constructed to a height of 44'-10".
