BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended to by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 3-I in the area bounded by

West Hirsch Street; North Artesian Avenue; a line 25 feet south of and parallel to West Hirsch Street; and the alley west of and parallel to North Artesian Avenue.

SECTION 2. This ordinance takes effect after its passage and approval.
