#### <u>ORDINANCE</u>

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.7-I in the area bounded by

a line 69.70 feet north of and parallel to West Logan Boulevard; North California Avenue; West Logan Boulevard; and a line 33.83 feet west of and parallel to North California Avenue,

to those of a B1-1 Neighborhood Shopping District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.




