BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the M3-3 Heavy Industry District symbols and indications as shown on Map No. 3-G in the area bounded by:

West Division Street; North Halsted Street; a southwesterly line 87.35 feet long beginning at a point 222.76 feet south of the south line of West Division Street (as measured along the west boundary line of North Halsted Street) and ending at a point 55.5 feet west of the west line of North Halsted Street and 290.16 feet south of the south line of West Division Street; a northwesterly line 10.33 feet long beginning at a point 55.5 feet west of the west of the west line of North Halsted Street and 290.16 feet south of the south line of West Division Street; a northwesterly line 10.33 feet long beginning at a point 55.5 feet west of the west Division Street and ending at a point 63.5 feet west of the south line of West Division Street; a southwesterly line 19.15 feet long starting at a point 63.5 feet west of the west line of North Halsted Street and 284.4 feet south of the south line of West Division Street; and ending at a point 63.5 feet west of the west line of North Halsted Street and 284.4 feet south of the south line of West Division Street; and ending at a point 63.5 feet west of the west line of North Halsted Street and 284.4 feet south of the south line of West Division Street and ending at a point 75.7 feet west of the west line of North Halsted Street and 284.4 feet south of the south line of North Halsted Street and 284.4 feet south of the south line of Street; the northeast boundary line of the South of the south line of West Division Street; the northeast boundary line of the Chicago River North Branch Canal, to the point of beginning,

SECTION 2. That the Chicago Zoning Ordinance be amended by changing all the C3-3 Commercial, Manufacturing and Employment District symbols to a Business Planned Development, and a corresponding use district is hereby established in the area above described.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance please be advised that on or about October 9, 2013, I, the undersigned, will file an application for a zoning amendment for the property located at 1150-1168 North Halsted Street, Chicago, Illinois. The application seeks to rezone the property from M3-3 Heavy Industry District to C3-3 Commercial, Manufacturing and Employment District and then to a Business Planned Development.
