ORDINANCE

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Business Planned Development No. 1170 symbols and indications as shown on Map Number 8-J in the area bounded by:

a line 553.91 south of and parallel to West 31st Street; South Kedzie Avenue; a line 1,010.17 feet south of and parallel to West 31st Street; a line 878.34 feet southwest of and almost parallel to South Kedzie Avenue and almost perpendicular to the centerline of the West Fork of the South Branch of the Chicago River as declared nonnavigable and filled; the centerline of the West Fork of the Chicago River,

to those of Business Planned Development No. 1170, as amended.

SECTION 2. This ordinance takes effect after its passage and approval.

Plan Of Development Statements.

- 1. The net site area delineated herein as Business Planned Development consists of approximately three hundred sixty-eight thousand five hundred eighty-one (368,581) square feet (8.46 acres) of property which is depicted on the attached Planned Development Boundary and Property Line Map (the "Property") and is owned and controlled by Azteca Mall, L.L.C. (the "Owner"). 3200 South Kedzie, L.L.C. makes this application with the consent of the Owner. For the purposes of these plan of development statements, the term "applicant" shall be deemed to mean Azteca Mall, L.L.C. notwithstanding that 3200 South Kedzie L.L.C. filed the application.
- 2. All applicable official reviews, approvals, or permits are required to be obtained by the applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys, or easements, or adjustments of rights-of-way, or consolidation or resubdivision of parcels, shall require a separate submittal on behalf of the applicant or its successors, assignees, or grantees and approval by the City Council.
- 3. The requirements, obligations, and conditions contained within this planned development shall be binding upon the applicant, its successors, and assignees and if different than the applicant, the legal titleholder and any ground lessors. All rights granted hereunder to the applicant shall inure to the benefit of the applicant's successors and assigns and if different than the applicant, then to the owners of record title to all of the Property and any ground lessors (including any condominium and/or owners' association which may be formed). Furthermore pursuant to the requirements of the Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time any application for amendments, modifications or changes (administrative, legislative, or otherwise) to this planned development is made, shall be under single ownership or under single designated control. Single designated control is defined in Section 17-8-0400 of the Chicago Zoning Ordinance ("Zoning Ordinance"). Nothing herein shall prohibit or in any way restrict the alienation, sale or any other transfer of all or any portion of the Property or any rights, interests or obligations therein. Upon any alienation, sale or any other transfer of all or any portion of the Property or the rights therein (other than an assignment or transfer of rights pursuant to a mortgage or otherwise as collateral for any indebtedness) and solely with respect to the portion of the Property so transferred, the term Applicant shall be deemed amended to apply to the transferee thereof (and its beneficiaries if such transferee is a land trust) and the seller or transferor thereof (and its beneficiaries if such seller or transferor is a land trust) shall thereafter be released from any and all obligations or liability hereunder with respect to the portion of the Property so transferred.

This planned development is in conformity with the intent and purposes of the Chicago Zoning Ordinance (Title 17 of the Municipal Code of Chicago) and all requirements thereof and satisfies established criteria for approval of a planned development. In any instance where a provision of this planned development conflicts with the Chicago Building Code, the Building Code shall control. This planned development conforms to the intent and purpose of the Chicago Zoning ordinance, and all requirements thereto and satisfies the established criteria for approval as a planned development. The following uses shall be permitted within the area delineated herein as Business Planned Development Number 1170, as amended: shopping mall and related uses including but not limited to retail establishments, restaurants, including live entertainment and dancing, and the serving of liquor in conjunction therewith; taverns, conference or meeting halls; grocery stores, personal services, day care, banking uses and financial services, artist work or sale space, Class I recycling facilities, Class II recycling facilities, and all other uses permitted in C3-1 Commercial, Manufacturing and Employment District except uses in the Residential Use Group, detention and correctional facilities, animal pounds, taxidermists, and colleges and universities, freestanding (towers) wireless communication facilities.

6. On-premise signs shall be permitted within the planned development subject to the review and approval of the Department of Housing and Economic Development (the "Department"). Temporary signs such as construction and marketing signs shall be permitted, subject to the review and approval of the Department. Off-premise signs are prohibited within the boundaries of the planned development.

7. Off-street parking shall be provided in compliance with this planned development. The minimum number of off-street parking spaces shall be determined in accordance with attached Bulk Regulations and Data Table.

- 8. Ingress or egress shall be subject to the review and approval of the Department of Transportation and the Department. Closure of all or part of any public street or alley during demolition or construction shall be subject to the review and approval of the Chicago Department of Transportation. All work proposed in the public way must be designed and constructed in accordance with the Chicago Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Chicago Department of Transportation.
- 9. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height restriction of any building or any appurtenance attached hereto shall not exceed the height established in the Bulk Regulations and Data Table and Building

Elevations and shall also be subject to height limitations established by the Federal Aviation Administration.

- 10. The maximum permitted floor area ratio for the entire parcel shall be in accordance with the attached Bulk Regulations and Data Table. For purposes of floor area ratio ("F.A.R.") calculations and floor area measurements, the definition of in the City of Chicago Zoning Ordinance shall apply. The permitted F.A.R. identified in the Bulk Regulations Table has been determined using a Net Site Area of three hundred sixty-seven thousand one hundred ninety-six (368,581) square feet.
- 11. Upon Part II Review, a Part II Review Fee shall he assessed by the Department of Zoning and Land Use Planning pursuant to Section 17-13-0610 of the Chicago Zoning Ordinance and Land Use Ordinance The fee, as determined by staff at the time, is final and binding on the applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
- 12. The terms, conditions and exhibits of this planned development may be modified administratively, pursuant to Section 17-13-0611-A of the Zoning Ordinance, by the Commissioner of the Department's Zoning and Land Use Division upon the application for such a modification by the applicant, its successors and assigns and, if different than the applicant, the legal titleholders and any ground lessors.
- 13. The applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioner of the Department of Streets and Sanitation, the Commissioner of the Environment and the Commissioner of Buildings under Section 13-32-125 of the Municipal Code of Chicago or any other provision of that Code.
