BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

A line 202.24 feet north of and parallel to West Chicago Avenue; the alley next east of and parallel to North LaSalle Street; West Chicago Avenue; North LaSalle Street

to the designation of Residential Business Planned Development No. 1219, as amended which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 2: This Ordinance shall be in force and effect from after its passage and due publication.







In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, for an approval under the Chicago Zoning Ordinance and an application for Residential Business Planned Development, please be informed that on or about December 6, 2013, I, the undersigned attorney, will file an application on behalf of the Applicant, Smithfield Chicago LaSalle LLC for a change in zoning from Residential Business Planned Development No. 1219 to Residential Business Planned Development No. 1219, as amended, for the property commonly known as 118-128 West Chicago Avenue, 801-819 North LaSalle Street, Chicago, Illinois and generally bounded by: A line 202.24 feet north of and parallel to West Chicago Avenue; the alley next east of and parallel to North LaSalle Street; West Chicago Avenue; North LaSalle Street.






D. EXISTING ZONING MAP

E. PROPERTY LINE AND RIGHT OF WAY ADJUSTMENT MAP



F. SITE PLAN / FIRST FLOOR / LANDSCAPE PLAN




G. GREEN ROOF DIAGRAM


H1. SOUTH ELEVATION ALONG CHICAGO AVENUE


H2. WEST ELEVATION ALONG LASALLE STREET


H3. EAST ELEVATION ALONG ALLEY


H4. NORTH ELEVATION


