Grant(s) of privilege in public way for South Shore Chamber, Inc. - trash container - 2660 E 79th St Committee on Transportation and Public Way ORDINANCE South Shore Chamber Inc Acct. No. 333432 - 40 Permit No. 1106354

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to South Shore Chamber Inc, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Trash container(s) on the public right-of-way adjacent to its premises known as 2660 E. 79th St.

Said Trash container(s) at E. 79th measure(s):

One (1) at two point six seven (2.67) feet in length, and two point six seven (2.67) feet in width for a total of seven point one three (7.13) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1106354 herein granted the sum of seventy-five (\$75.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
