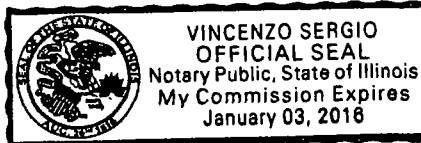



## PROJECT NARRATIVE

### **3200-3226 North Clark Street and 854-856 West Belmont Avenue, Chicago, Illinois**

The Applicant is seeking to amend the zoning at the subject property from a B3-3 Commercial Shopping District to a B3-5 Commercial Shopping District and then to a Residential-Business Planned Development (“the Planned Development”) in order to locate and establish an eleven-story mixed-use building at the site.

The property is currently improved with a two-story (with one-story rear addition) commercial building and two (2) one-story commercial buildings (fronting Clark Street); a two-story (with one-story rear addition) mixed-use building (fronting Belmont Avenue); and an asphalt parking lot (located at the corner of Clark and Belmont). If the proposed Planned Development is approved, the Applicant intends on razing the four existing buildings and parking lot, to allow for the redevelopment of the property with a new-eleven-story mixed-use building.

The proposed Planned Development will consist of 25,725 square feet (0.59 acres) of land. The Planned Development will permit the construction of a new eleven-story mixed-use (commercial/residential) building at the site. The proposed new building will contain 50,035 sq. ft. (approx.) of commercial/retail space (located within the basement, 1<sup>st</sup> and 2<sup>nd</sup> floors). The proposed new building will contain 100 residential dwelling units (located within the 3<sup>rd</sup> through 11<sup>th</sup> floors) and 116 interior parking spaces (located within the 3<sup>rd</sup> through 5<sup>th</sup> floors). A lobby for the retail tenants and customers will be located at grade level, with an entrance off of Belmont Avenue. Entry for the residential tenants and guests will be located off of Clark Street, near the north end of the building.

Amenities for the residents will be located on the 6<sup>th</sup> floor and will include, *inter alia*, (i) a fitness center, (ii) a party room, (iii) a business center, and (iv) an outdoor dog run. There will also be a communal recessed outdoor terrace on the 6<sup>th</sup> floor as well as a private terrace (along the public alley) for residents occupying some of the units located on the 6<sup>th</sup> floor. Another small private roof deck is intended for the 9<sup>th</sup> floor.


The proposed new building will be “tiered”, with the highest point (121'-0” approx./ 11 stories) located at the corner of Belmont Avenue and Clark Street. The building, at its lowest point on Belmont Avenue, will measure approx. 60'-0” (5 stories). On Clark Street, the building at its lowest point will measure approx. 90'-0” (8 stories). The proposed new building will be masonry in construction, with metal and glass accents.

The proposed Planned Development will be securely maintained 24 hours a day, 7 days a week. All commercial/retail activities and services, however, will occur between the hours of 6:00 a.m. and midnight, 7 days a week. The Applicant is still in the process of evaluating bids for the proposed commercial/retail space. No tenants have been confirmed, nor leases executed, to date.



**RESIDENTIAL-BUSINESS PLANNED DEVELOPMENT NO. \_\_\_\_\_**  
**PLAN OF DEVELOPMENT STATEMENTS**

1. The area delineated herein as Residential-Business Planned Development No. \_\_\_\_\_ (the "Planned Development") consists of approximately twenty-five thousand, seven hundred and twenty-five (25,725) square feet, plus or minus point fifty-nine (0.59) acres, of property (the "Property"), which is depicted on the attached Planned Development Boundary and Property Line Map, and which is owned or controlled by the Applicant, **3200 N. Clark, LLC** (the "Applicant").
2. All applicable official reviews, approvals or permits are required to be obtained by the Applicant, or its successors, assignees or grantees. Any dedication or vacation of streets, alleys or easements or any adjustment of the right-of-way shall require a separate submittal on behalf of the Applicant, or its successors, assignees or grantees, and approval by the City Council.
3. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns, and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. "Designated control" for the purpose of this paragraph shall mean that any application to the City for any amendments to this Planned Development, or any other modification or change thereto (administrative, legislative or otherwise), shall be made or authorized by the owners of the Property and any ground lessors. An agreement among property owners, the board of directors of any property owner's association, or a covenant binding upon any property owner, may designate the authorized party for any future amendment, modification or change.
4. This Plan of Development consists of seventeen (17) Statements, including *inter alia*: a Bulk Regulations and Data Table; an Existing Zoning Map; a Planned Development Boundary and Property Line Map; an Existing Land-Use Map; and a Site Plan, Landscape Plan and Building Elevations, prepared by Hirsch Associates LLC Architecture & Planning, and dated December 12, 2013, submitted herein. Full sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Housing and Economic Development ("DHED"). These, and no other zoning controls, shall apply to this property. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall apply. This Planned Development conforms to the intent and purpose of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago and all requirements thereto and satisfies the established criteria for approval as a Planned Development.

The following uses, *inter alia*, are allowed in the area delineated herein as “Residential-Business Planned Development No. \_\_\_\_\_”: residential units (both D.U.s and E.U.s), all business and commercial uses allowed by within a C3 Community Shopping District, including all related and accessory uses, and off-street parking and loading.
6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of DHED. Off-Premise signs are prohibited within the boundary of this Planned Development.
7. Off-street parking and loading facilities shall be provided in compliance with this Planned Development subject to the review of the Chicago Department of Transportation (“CDOT”) and the approval of DHED.
8. Ingress or egress shall be subject to the review and approval by CDOT and DHED. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of CDOT. All work proposed in the public way must be designed and constructed in accordance with CDOT’s Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago.
9. The height of any building or any appurtenance attached shall not exceed the height established in the attached Bulk Regulations and Data Table and Building Elevations, and shall also be subject to height limitations established by the Federal Aviation Administration (“FAA”).
10. The maximum permitted floor area ratio (“FAR”) for the Property shall be in accordance with the attached Bulk Regulations and Data Table. For the purposes of FAR calculations and floor area measurements, the definitions in the Chicago Zoning Ordinance shall apply.
11. The City of Chicago established a Part II Review Fee in the Amount of \$ 0.25 per square feet for the total buildable square feet (FAR). The Part II Review Fee is assessed by DHED during the actual Part II Review. The fee, as determined by DHED staff at that time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II Approval.
12. The improvements on the property, including the on-site exterior landscaping and the landscaping along the adjacent rights-of-way and all entrances and exits to and from the parking and loading areas, shall be designed, constructed and maintained in substantial conformance with the attached Site Plan and Landscape Plan. In addition, parkway trees shall be installed and maintained in accordance with the parkway tree planting provisions of the Chicago Zoning Ordinance and corresponding regulations and guidelines.

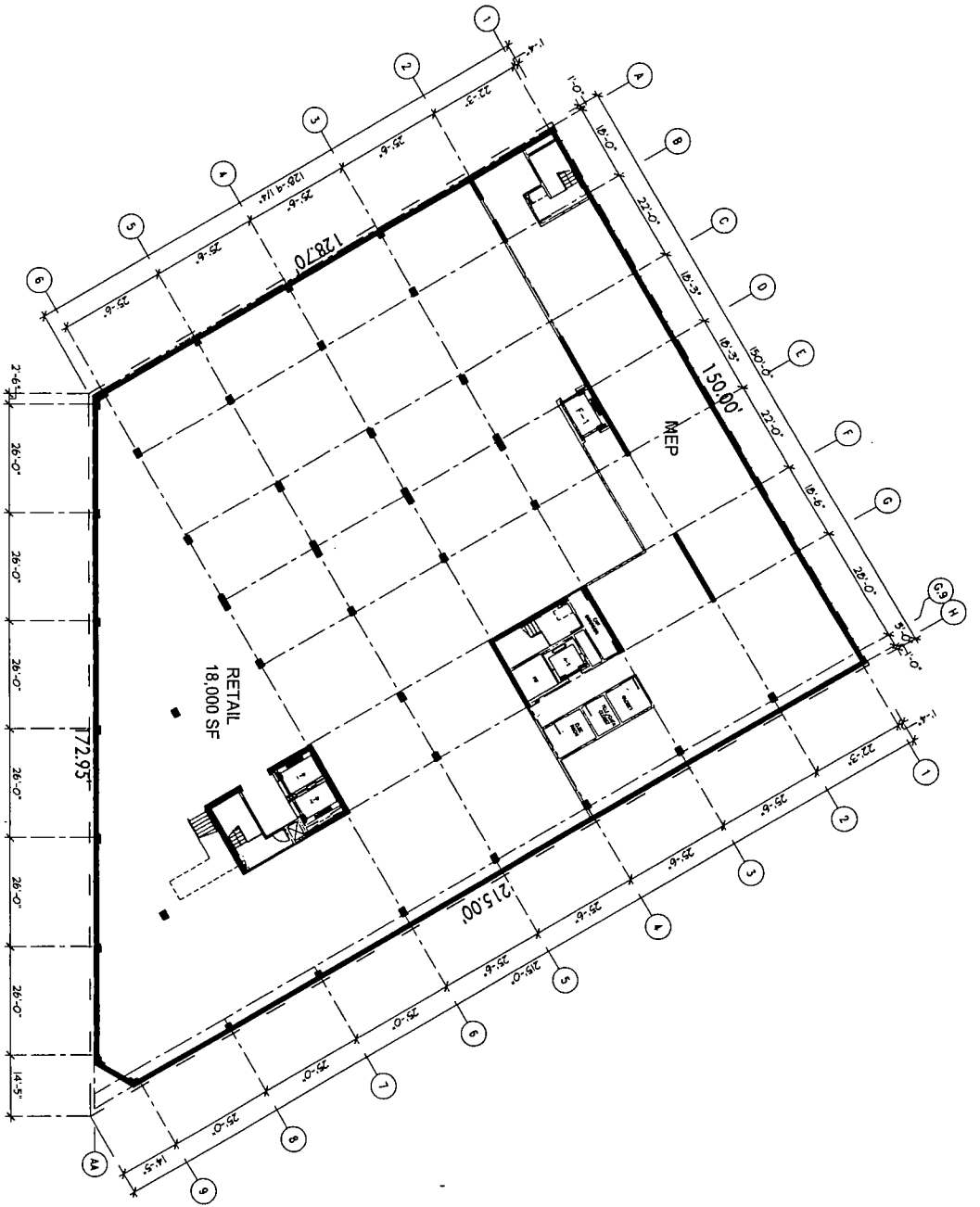
