ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M3-3 Heavy Industry District symbols and indications as shown on Map No.5-H in the area bounded by

the alley next northeast of North Elston Avenue; the alley next east of and parallel to North Elston Avenue; a line 375 feet southeast of the intersection of West Fullerton Avenue and North Elston Avenue as measured along the northeasterly right-of-way line of North Elston and perpendicular thereto; North Elston Avenue; and a line 300 feet southeast of the intersection of West Fullerton Avenue and North Elston Avenue as measured along the northeasterly right-of-way line of North Elston Avenue and perpendicular thereto,

to those of a C1-3 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

11. Current Use of the Property: The property consists of three (3) lots of record (Lot 19, Lot 20 and Lot 21). Lot 19 and Lot 20 are vacant. Lot 21 is currently improved with a two-story brick building and a one-story block building. The buildings are vacant.
12. Reason for rezoning the property: The Applicant is seeking to amend the zoning at the subject property in order to permit the location and establishment of a children's day care facility at the site.
13. Describe the proposed use of the property after the rezoning. Indicate the number of dwelling units; number of parking spaces; approximate square footage of any commercial space; and height of the proposed building. (BE SPECIFIC)
The existing two-story building and one-story building will, both, be razed. The proposed zoning amendment will allow the Applicant to redevelop the site with a new two-story building (13,549.75 sq.ft.), which will be used for operating a children's day care facility. The proposed new building will contain interior (lower level) on-site parking for thirteen (13) vehicles and a roof top (open air) playground.

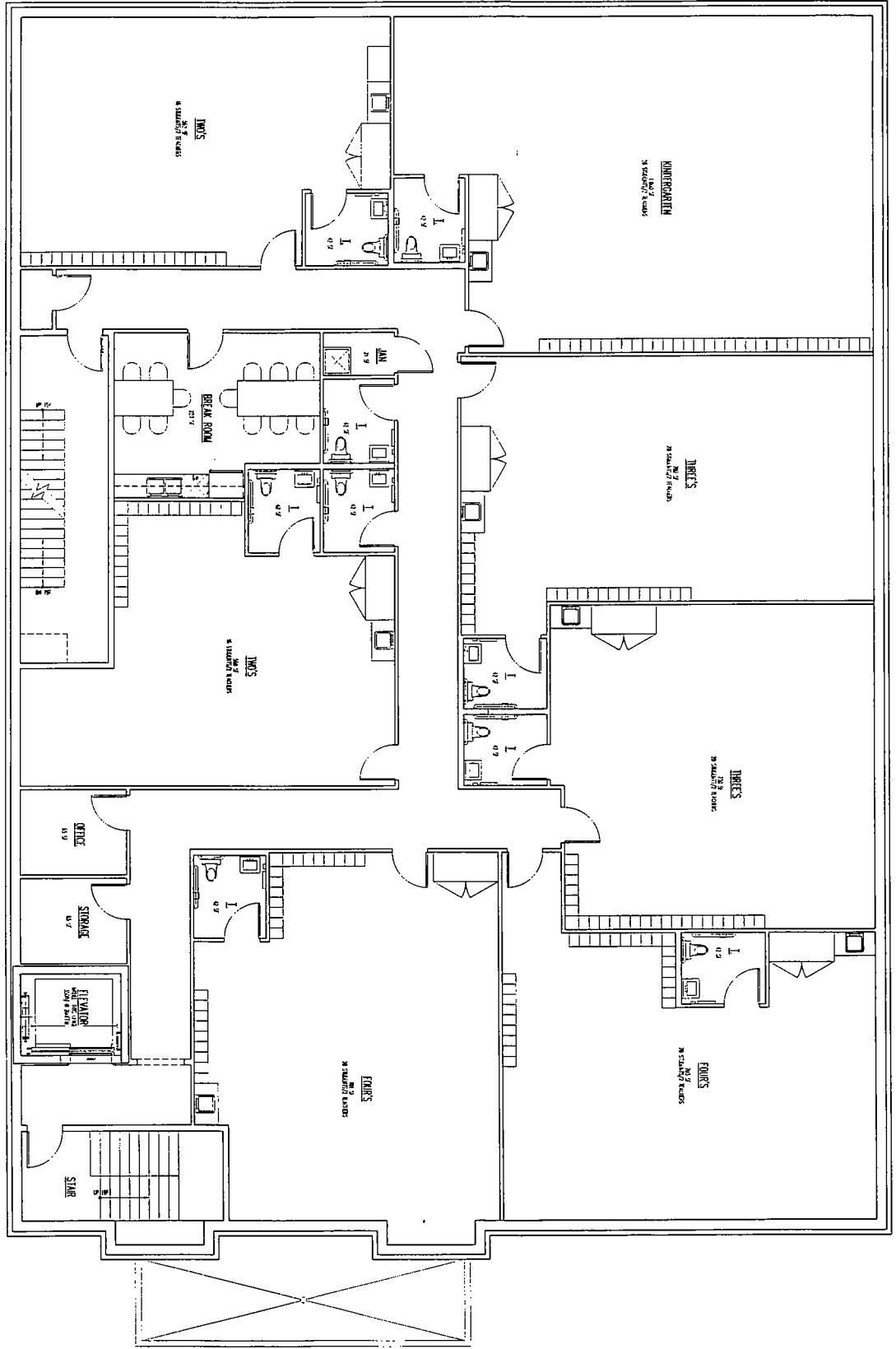

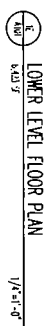


FIRST FLOOR PLAN
