As required by Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about January 29, 2014, the undersigned, on behalf of FRC Realty, Inc. (the "Applicant"), intends to file an application to rezone the property located at 350-360 West Chestnut, 341-361 W. Chestnut Street, and 836-848 N. 



Planned Development Property Line and Boundary Map





Sub-Area A Green Roof Plan








