a line 92.46 feet north of and parallel to West Chestnut Street; a line 130.19 feet east of and parallel to North Sedgwick Street; a line 109.04 feet north of and parallel to West Chestnut Street; the public alley next west of and parallel to North Orleans Street; West Chestnut Street; North Orleans Street; the public alley next south of and parallel to West Chestnut Street; the public alley next west of and parallel to North Orleans Street; the public alley next south of and parallel to West Chestnut Street; a line 213.42 feet west of and parallel to North Orleans Street; a line 142.41 feet south of and parallel to West Chestnut Street, as extended; North Sedgwick Street,

to those of C2-5 Motor Vehicle-Related Commercial District.

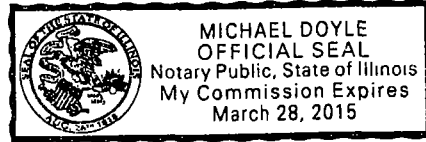



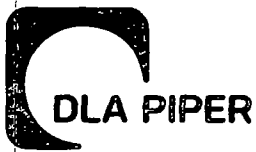

As required by Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about January 29, 2014, the undersigned, on behalf of FRC Realty, Inc. (the "Applicant"), intends to file an application to rezone the property located at 350-360 West Chestnut, 341-361 W. Chestnut Street, and 836-848 N. Orleans Street, Chicago, Illinois from the C1-2 Neighborhood Commercial District to the C2-5 Motor Vehicle-Related Commercial District and then to Residential-Business Planned Development.

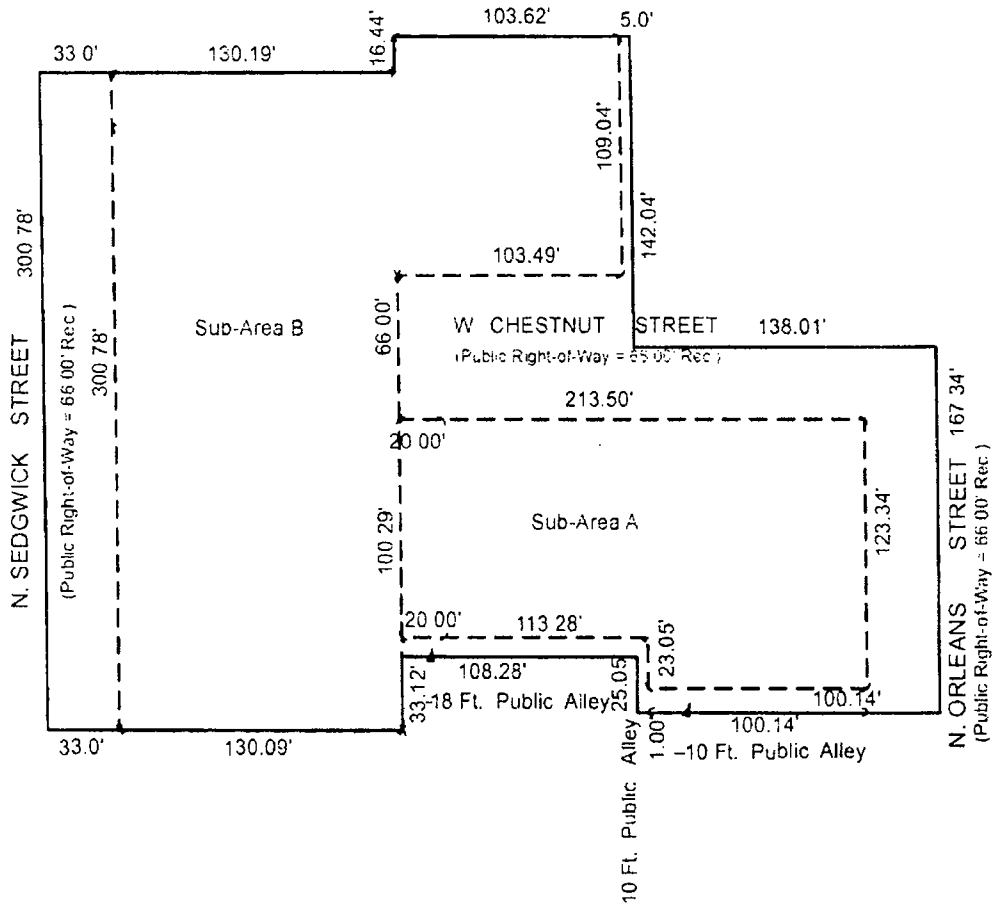

**PLANNED DEVELOPMENT STATEMENTS**

1. The area delineated herein as Planned Development Number \_\_\_\_ (“Planned Development”) consists of approximately 74,244 net square feet which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”). The “Applicant” for purposes of this Planned Development, FRC Realty, Inc., has filed an application for planned development approvals with the written authorization of BPRS/Chestnut Venture Limited Partnership, the beneficial owner of the Property.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessees. All rights granted hereunder to the Applicant for each of the two Sub-Areas delineated herein shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessees with respect to such Sub-Areas.

Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance, and it is specifically the intent of the Applicant and the beneficial owner of the Property, and their successors and assigns, that the owner of each Sub-Area from time to time may seek changes to this Planned Development (whether administrative, legislative or otherwise) as it applies to its own Sub-Area without the consent of the owner(s) of the other Sub-Area, provided such change complies with the requirements of Section 17-8-0400, i.e., such that such change shall not: (i) reduce any bulk, density, parking or similar development requirement generally available or applicable to all Sub-Areas, such as any unused bulk or density rights; (ii) materially adversely reduce another Sub-Area owner's right of access; (iii) materially adversely reduce open space, walkways, or similar design requirements applicable to one or more Sub-Areas; or (iv) render another Sub-Area a non-conforming use.

Notwithstanding the foregoing, following (and only following) completion of the improvements to Sub-Area A contemplated by the Plans (defined below) or other plans for Sub-Area A submitted by the Applicant and approved by the Department of Housing and Economic Development in accordance with this Planned Development, the owner of Sub-Area B shall have the right to seek a minor change for the purpose of transferring remaining unused floor area and dwelling units, if any, from Sub-Area A to Sub-Area B; provided, however, any such transfer shall be in reference to a specific development proposal, and in no event shall such a transfer be permitted if it would or could result in

the improvements to Sub-Area A becoming non-conforming to this Planned Development or the Chicago Zoning Ordinance.

3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of 15 Statements; a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; a Sub-Area Map; a Site Plan; a Landscape Plan; a Green Roof Plan; Building Elevations (North, South, East and West) and a Chicago Builds Green form, all prepared by Pappageorgehaymes Partners and dated \_\_\_\_\_, 2014, submitted herein (collectively, the "Plans"). Full-sized copies of the Plans are on file with the Department of Housing and Economic Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. These and no other zoning controls shall apply to the Property.
5. In each of the following Sub-Areas, the following uses shall be permitted in this Planned Development: (1) all uses permitted in the C2-5 Motor Vehicle-Related Commercial District including, without limitation, multi-family dwelling units above the ground floor, retail sales, eating and drinking establishments and offices; and (2) schools, colleges, universities, vocational training and culinary institutes.

6. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
7. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted overall FAR identified in the Bulk Regulations Table has been determined using an overall Net Site Area of 74,244 square feet.
8. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
9. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
10. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
11. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessees.
12. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
13. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. A green roof of not

less than 50% of the net roof area shall be provided in Sub-Area A. The improvements in Sub-Area A shall be designed and constructed in a manner generally consistent with LEED certification.

14. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Housing and Economic Development shall initiate a Zoning Map Amendment to rezone the property to the C2-5 Motor Vehicle-Related Commercial District existing immediately prior to the adoption of this amended Planned Development.
15. The Applicant acknowledges and agrees that the rezoning of the Property to allow household living uses pursuant to this Planned Development triggers the requirements of Section 2-45-110 of the Municipal Code (the "Affordable Housing Ordinance"). Any developer of a "residential housing project" within the meaning of the Affordable Housing Ordinance ("Residential Project") must: (i) develop affordable housing units as part of the Residential Project; (ii) pay a fee in lieu of the development of affordable housing units; or (iii) any combination of (i) and (ii). 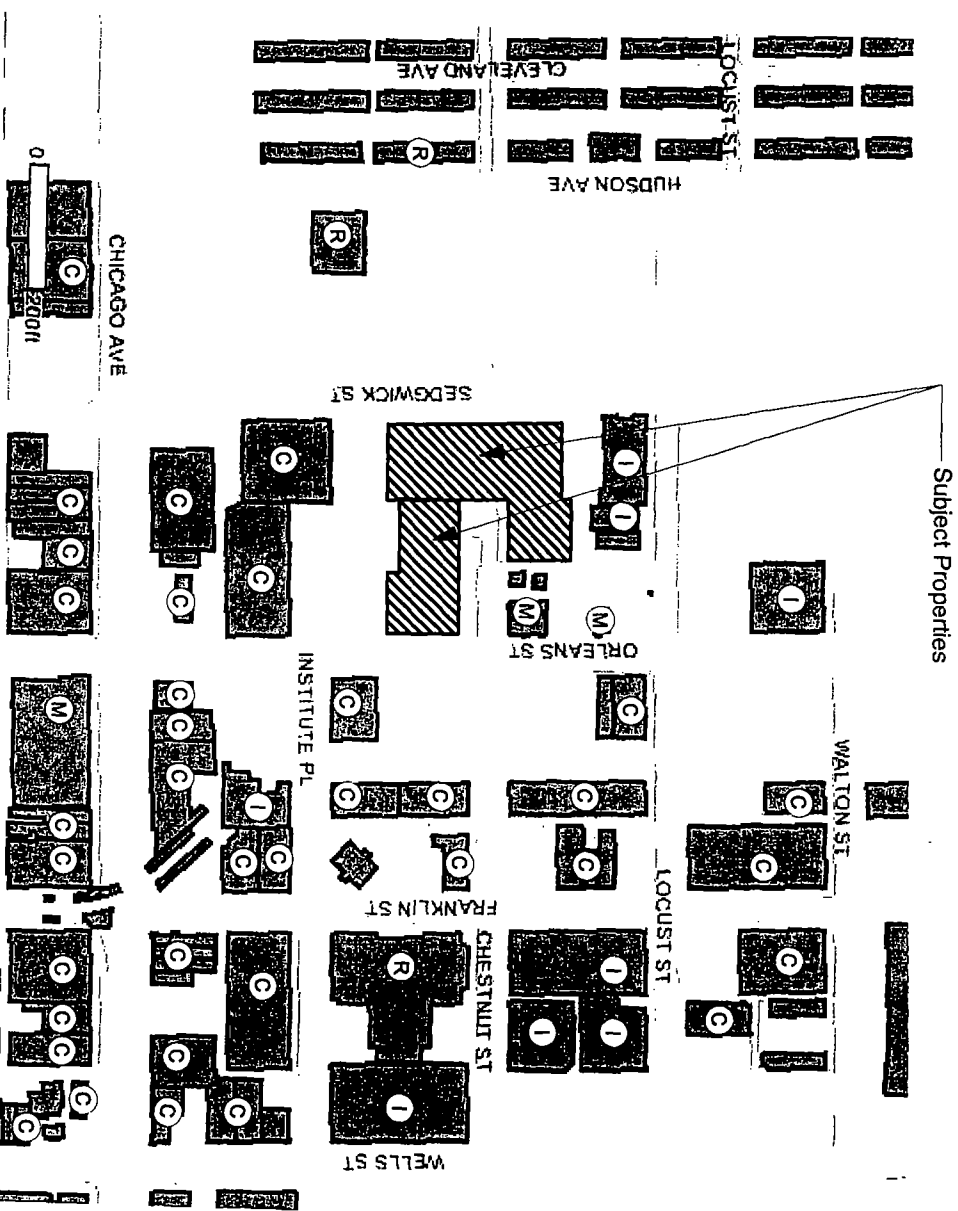

**South Elevation**

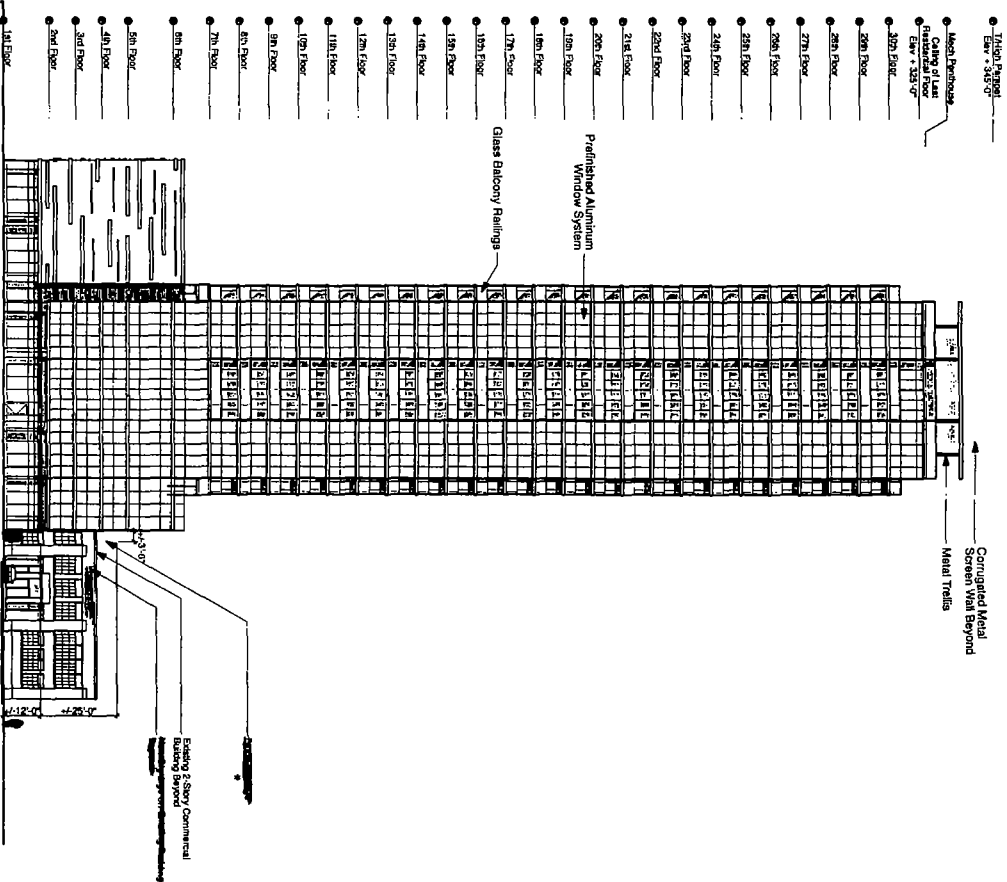
