**SECTION 1.** That the Chicago Zoning Ordinance be amended by changing all of the DX-16 Downtown Mixed-Use District symbols and indications as shown on Map 1-E in the area bounded by:

East Wacker Drive; North Michigan Avenue; North MacChesney Court; North MacChesney Court; and a line approximately perpendicular to the southeasterly line of East Wacker Drive, extending from a point on the southeasterly line of East Wacker Drive located approximately 180.94 feet southwest of the intersection of the southeasterly line of East Wacker Drive and the south line of East Wacker Drive; East Wacker Drive

to those of Planned Development.

**SECTION 2.** This Ordinance shall be in force and effect from and after its passage.







In accordance with the requirements of Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about January 29, 2014, the undersigned, as an attorney acting on behalf of AG-OCG 360 North Michigan, L.L.C. (the "Applicant"), intends to file an application to amend the Chicago Zoning Ordinance relating to the property located at 360 North Michigan Avenue and 83-87 East Wacker Drive in Chicago, Illinois (the "Property"). 

The report shall be submitted as part of the Part II Review application to the Historic Preservation Division and be subject to the review and acceptance of the Department of Housing and Economic Development.

9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. The building will exceed ASHRAE 90.1-2004 by approximately 14%.

Pursuant to the Adopt-a-Landmark Bonus provisions of Section 17-4-1022 of the Zoning Ordinance, the Applicant has requested an increase in the floor area of the Property based on the proposed restoration of the Landmark Building (the "Landmark Project"), which is located on the Property. Pursuant to Section 17-4-1022 of the Zoning Ordinance, the Commissioner of the Department (the "Commissioner"), acting on behalf of the City and the Landmarks Commission, is authorized and directed to enter into an agreement with the Applicant and, if different from the Applicant, the owner(s) of the Landmark Building, regarding the manner in which funds for renovation work in the Landmark Project relating to the Adopt-A-Landmark Bonus, as approved by the Landmarks Commission, will be used. On \_\_\_\_\_, the Landmarks Commission approved a Scope of Work and Budget for the Landmark Project, providing for the expenditure of \$ \_\_\_\_\_ in project costs, of which \$177,940 corresponds to a floor area bonus of 0.34. The agreement shall be in a form approved by the Corporation Counsel and shall be executed and submitted to the Department prior to the issuance of any approvals pursuant to Section 17-13-0610 of the Chicago Municipal Code ("Part II"). The terms and conditions of the Landmark Project Scope of Work and Budget may be modified administratively by the Commissioner in accordance with the provisions of Statement 13 of this Planned Development and as described in the Landmark Project Scope of Work and Budget. Upon completion of the work related to the Landmark Project, the Applicant shall apply to the Landmarks Commission for the issuance of a Certificate of Completion of the Landmark Project. The Applicant shall provide written notice of said application to the Landmarks Commission, the Office of the Zoning Administrator, the Department of Law, and the Department. The work described on the Landmark Project Scope of Work and Budget must be completed and a Certificate of Completion of the Landmark Project must be obtained from the Commission on Chicago Landmarks prior to the issuance of any certificate of occupancy for the Property.
16. This Planned Development shall lapse unless substantial rehabilitation of the Landmark Building and substantial construction of the proposed building addition have commenced within three years of the date of City Council approval of this Planned Development; provided that this three-year period may be extended by up to one additional year in accordance with Section 17-13-0612-B of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Housing and Economic Development shall initiate a Zoning Map Amendment to rezone the Property to the DX-16 Downtown Mixed-Use District.








EXISTING CITY ZONING MAP







ROOF PLAN




