ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the C2-3 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 3-F in the area bounded by:

West Scott Street; North Wells Street; a line 133 feet south of and parallel with the south line of West Scott Street; a line 240.77 feet west of and parallel with the west line of North Wells Street,

to those of a Residential-Business Planned Development, which is hereby established in the area described, subject to such use and bulk regulations as are set forth in the attached Plan of Development.

SECTION 2: This ordinance shall take effect upon its passage and due publication.

PLANNED DEVELOPMENT STATEMENTS

- 1. The area delineated herein as Residential-Business Planned Development Number

 ("Planned Development") consists of approximately 31,988 square feet (0.734 acres) of property which is depicted on the attached Planned Development Boundary and Property Line Map ("Property") and is owned or controlled by the Applicant, Wells and Scott Development Partners LLC.
- 2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the applicant's successors and assigns and, if different than the applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined section 17-8-0400 of the Zoning Ordinance.
- 3. All applicable official reviews, approvals or permits are required to be obtained by the applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assign or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the plans.

Ingress or egress shall be pursuant to the plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of these 15 Statements: a Bulk Regulations and Data Table; an Existing Site Aerial Map; an Existing Zoning Map; an Existing Land Use Map; a Planned Development Boundary and Property Line Map; a Site/Landscape Plan; a

In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Housing and Economic Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
- For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. 7. The height of any building shall also be subject to height limitations established by the Federal Aviation Administration.
- The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance 8. with the attached Bulk Regulations Table. For the purposes of FAR calculations and

measurements, the definitions in the Zoning Ordinance shall apply; however, in addition to the other exclusions from Floor Area for purposes of determining FAR permitted by the Zoning Ordinance, all floor area devoted to mechanical equipment in excess of five thousand (5,000) square feet in a contiguous location, regardless of placement in the building, shall be excluded. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 31,988 square feet.

- 9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
- 10. The Site and Landscape plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development.

Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.

- 11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Department of Streets and Sanitation, and the Department of Fleet and Facility Management, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
- 12. The terms and conditions of development under this the Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
- 13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
- 14. The applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. At the time of a hearing before the Chicago Plan Commission, all developments must be in substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Housing and Economic Development. that bring it into compliance with the Sustainable Development Policy include the following: The project shall obtain LEED, Energy Star or Chicago Green Homes certification and will include a minimum of 50% green roof (11,600 s.f. green area).

This Planned Development shall be governed by Section 17-13-0612 of the Zoning 15. Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Housing and Economic Development shall initiate a Zoning Map Amendment to rezone the property to C2-3 Motor Vehicle-Related Commercial District.


EXISTING SITE AERIAL MAP





Pursuant to the provisions of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, the Department of Housing and Economic Development hereby submits this report and recommendation on a proposed Planned Development for your review and recommendation to the Chicago City Council. The application was introduced to the Chicago City Council on October 16, 2013. Notice of this public hearing was published in the <u>Chicago Sun-Times</u> on December 04, 2013. The Applicant was separately notified of this public hearing.

The property is identified as <u>201-223 W. Scott Street</u> and is generally located on the Southwest corner of Scott Street and Wells Street. The applicant Wells and Scott Development Partners, LLC proposes to construct a 6 story, 71 dwelling unit building with ground floor retail space and 71 parking stalls.

This request is being submitted as a mandatory planned development, pursuant to Section 17-08-0513-A, due to the proposed unit count exceeding the threshold of 60 units.

PROJECT BACKGROUND AND DESCRIPTION

The Applicant and Owner, Wells and Scott Development Partners LLC, has filed this mandatory planned development application pursuant to section 17-08-0513-A, the proposed project will exceed the maximum 60 dwelling unit threshold. The project will consist of a 6 story building, the ground floor will house retail space and the floors above will be compromised of 71 parking stalls and 71 dwelling units. Access to the (1) one loading berth and the parking stalls will be from (2) driveways along Scott Street.

SITE AND AREA DESCRIPTION

The subject property is located at the intersection of West Scott Street and North Wells Street and is located adjacent to a mix of land uses. On the Eastern edge

of the site is a parcel of land zoned residential business planned development #1148. South of the site are parcels zoned C1-5 Neighborhood Commercial District and Planned Development # 403. West of the site are properties zoned RM-5, Residential Multi-Unit District. Directly north of the site is property zoned C1-5 Neighborhood Commercial District and Planned Development #601. The site is also not in the Lake Michigan and Chicago Lakefront Protection District. The site is located within the Near North Tax Increment Financing (TIF) District.

The site consists of approximately 31,988 square feet (0.734 acres) and is currently a vacant lot. Aerial photographs suggest that the site had previously been used as a parking lot. The proposed development would consist of a mixed use of retail on the first floor with 71 dwelling units above the ground floor. The building would also contain 71 parking spaces. The off-street parking spaces on the site are accessed from (1) one new driveway along West Scott Street. The loading berth would be accessed from a separate new driveway also located along West Scott Street.

The CTA's bus route # 22 (Clark), route #36 (Broadway), route #37 (Sedgwick), route #70 (Division) and route # 156 (LaSalle) all run on streets within a half-mile of the site. The North/Clybourn, Clark/Division, Chicago, and Grand stations on the CTA's Red Line and the Sedgwick and Chicago station along the CTA's Brown Line are within a one mile radius from the site. There are no METRA stations within a one mile radius from the site.

DESIGN

The project is located at the intersection of Wells Street -- a heavily trafficked, retail thoroughfare -- and Scott Street, a quiet, residential cul-de-sac. The architectural design harmonizes these elements by thoughtfully balancing the scale of both streets. The building exterior is clad in modular brick, charcoal gray metal panels, and insulated glass windows, materials commonly found on Wells Street buildings. Massing is concentrated along the busier pedestrian-oriented street; retail space is located along Wells, with balconies on the upper floors to help activate that façade. In contrast, the residential entrance and ground-floor amenities are located along the quieter Scott Street face. The residential entrance and retail space conceal all 71 parking spaces from street view. The project will also feature a green roof and rooftop amenity room for the 71 residential units

LANDSCAPING

The project will provide at grade landscape areas and street tree plantings; the entire planned development will be compliant with the requirements of the Chicago Landscape Ordinance.

ACCESS / CIRCULATION

All required parking stalls will be provided within the proposed building. The parking will be accessed from a driveway off of Scott Street. The subject site

also has one loading berth to serve the building; this loading area will be accessed from a separate driveway also located along Scott Street.

The two public streets, Scott Street and Wells Street, are both currently operating as two way traffic flow and will continue to operate as such. The historical access to a parking lot was off of the Wells Street frontage, this curb cut will be removed and sidewalk, curb, and gutter will be restored per CDOT standards.

SUSTAINABILITY

The subject site will be designed to be in compliance with the current City of Chicago Sustainable Development policy as set forth in the Department of Housing and Economic Development's Green Matrix.

The building will accommodate a 50% green roof, approximately 11,600 square feet in area. In addition this building will obtain LEED, Energy Star, or Chicago Green Homes certification.

BULK / USE / DENSITY

The current maximum allowable Floor Area Ratio (FAR) for the proposed underlying zoning district (C2-3) is 3.0; the proposed planned development will be limited to this maximum and the current proposed project calls for a 3.0 FAR. Prior to filing for a planned development the subject property was reviewed and approved at the Zoning Board of Appeals (ZBA) for the reduction of minimum side setback on a reversed corner lot from the required 7.16' to 0 feet, and also to reduce the west rear yard setback to 3.69' instead of the required 4.68'. The proposed planned development will maintain these previously approved setbacks and be in compliance with all other setbacks requirements as per the accompanying plans. All remaining bulk, use and density items will be in substantial compliance with the stipulations of Section 17-3-0400 for C2-3 zoning districts, per section 17-8-0901.

RECOMMENDATION

The Department of Housing and Economic Development has reviewed the project materials submitted by the Applicant and compared this proposal to the requirements of the Chicago Zoning Ordinance and existing development in the community. The area around this project is a diverse mix of commercial, residential and planned development uses and is accessible from numerous forms of public transit. Based on that analysis, DHED has concluded that this proposal is appropriate for this site and supports this development for the following reasons:

- 1. Ensures adequate public review of major development proposals (per 17-8-0101), as evidenced by the July 22, 2012, public meetings held in the community by the local alderman and Applicant;
- 2. Promotes unified planning and development (per 17-8-0102), as evidenced through the design which strives to maintain a balance between the retail and residential components of the site by providing

- ease of access to retail options for pedestrians while still providing viable parking options for the residents of the building all the while maintaining a building that is in context and character with the neighboring area;
- 3. Promotes economically beneficial development patterns that are compatible with the character of existing neighborhood (per 17-8-0103), as evidenced by the design, massing and proposed uses being in context with the character and needs of the immediate community;
- 4. Ensure a level of amenities appropriate to the nature and scale of the project (per 17-8-0104), as evidenced by amenities provided to the residential units in the project plans as well as by the retail options being provided to the area residents while being in accordance with the requirements of the Chicago Zoning Ordinance;
- 5. Promotes a flexible application of selected bulk, use and development standards to provide a creative, urban design (per 17-8-0105), as evidenced through elevation details and material selections;
- 6. Promotes transit, pedestrian and bicycle use, ensures accessibility for persons with disabilities and minimizes conflicts with existing traffic patterns in the vicinity (per 17-8-0904-1-2, 3 & 4), as evidenced through the site's close proximity to various methods of public transit, the accessibility accommodations made on-site for the building residents as well as for the retail users, pedestrian and bicycle ingress and egress options provided to the building residents and retail uses, and lastly the design of the building to fit current existing traffic patterns at the site.
- 7. Provides buildings abutting the sidewalk with doors windows and active use adjacent to it (per 17-8-0905-B-1), as evidenced by the site plan provided showing the building edge immediately adjacent to the public sidewalk and to be improved with retail and restaurant uses which will provide windows, door and active uses adjacent to the public sidewalk.
- 8. Provides structures that allow for pedestrian entrance from the surrounding sidewalks (per 17-8-0905-B-2), as evidenced by the construction to the edges of the site's property lines and the use of distinct materials to highlight the entrance points of the building.
- 9. All sides and areas of the buildings that are visible to the public should be treated with materials, finishes, and architectural details that are of high-quality and appropriate for use on primary public-right-of-wayfacing façade (per 17-8-0907-A-4), as evidenced through the information contained within this report, the materials as called out on the elevations in the exhibits to this planned development, and the corresponding proposal renderings;
- 10. Promotes environmentally sustainable development practices (per 17-9-0908-A), as evidenced by the project providing a 50% green roof and committing to obtain LEED, Energy Star or Chicago Green Homes certification.

The project meets the purpose and criteria set forth in the Chicago Zoning Ordinance and its adoption would not have any adverse impact on the public's health, safety or welfare:

- Per 17-13-0308-C, the proposed development is compatible with surrounding commercial, institutional and residential development in terms of land use, as well as, the density and scale of the physical structure.
- 2. Per 17-13-0308-D, the proposed underlying zoning for this planned development (C2-3) is consistent with other businesses and commercial zoning districts, both adjacent to this site and in the immediate area.
- 3. Per 17-13-0308-E, the public infrastructure facilities and City services will be adequate to serve the proposed development at the time of occupancy and the project will comply with the requirements for access in case of fire and other emergencies. The proposed project has been reviewed by the Mayor's Office for People with Disabilities and the Department of Transportation and all requested changes have been made. Copies of this application have been circulated to other City departments and agencies and no comments have been received which have not been addressed in the application.

Based on the foregoing, it is the recommendation of the Department of Housing and Economic Development that this application for the establishment of a Planned Development be approved and that the recommendation to the City Council Committee on Zoning Landmarks and Building Standards be "Passage Recommended".

- WHEREAS, the Plan Commission has fully reviewed the application and all associated informational submissions, the report and recommendation of the Department of Housing and Economic Development and all other testimony presented at the public hearing held on December 19, 2013, giving consideration to the applicable provisions of the Zoning Ordinance.

NOW, THEREFORE, BE IT RESOLVED BY THE CHICAGO PLAN COMMISSION:





"Applicable Party" means (1) all executive officers of the Disclosing Party listed in Section II.B.1.a., if the Disclosing Party is a corporation; all partners of the Disclosing Party, if the Disclosing Party is a general partnership; all general partners and limited partners of the Disclosing Party, if the Disclosing Party is a limited partnership; all managers, managing members and members of the Disclosing Party, if the Disclosing Party is a limited liability company; (2) all principal officers of the Disclosing Party; and (3) any person having more than a 7.5 percent ownership interest in the Disclosing Party. "Principal officers" means the president, chief operating officer, executive director, chief financial officer, treasurer or secretary of a legal entity or any person exercising similar authority.
